

**Bids will be publicly opened at 10:00 A.M. on THURSDAY, JULY 31, 2025.**

The City is not responsible for delays occasioned by the U.S. Postal Service, the internal mail delivery system of the City, or any other means of delivery employed by Bidder. Similarly, the City is not responsible for, and will not open, any bid/proposal responses, which are received later than the date and time indicated above. Late bids/proposals will be retained in the bid/proposal file, unopened.

**TERM OF CONTRACT**

Any contract resulting from this ITB will become effective upon bid award. Per Section 3-3-7(7) of the Birmingham City Code and State Bid Law, the proposed contract shall be in effect for a minimum of one (1) year guaranteed with the option of renewal for two (2) additional one-year terms, contingent upon Council approval. **The life of this contract shall exist with the approval of both parties with the provision that no price increase in the original bid prices shall be allowed.**

**ADDENDA**

Any addenda will be available on the internet. Bidder is responsible for checking the website for addenda until the bid opening date. Addenda will be mailed to only those vendors who were provided a copy in person or by mail.


**CERTIFIED CHECK/BID BOND/CASHIER’S CHECK**

It is required for any contract exceeding \$10,000.00 that the bidder submits with his bid a certified check, a cashier’s check, or a bid bond payable to the City of Birmingham. In order for any bid award to be considered that exceeds \$10,000.00, your bid must be accompanied by an acceptable bid bond, cashier’s or certified check in the amount of \$1,000.00. Bid bond checks will be returned to all unsuccessful bidders after the formal award is made and to the successful bidder after acceptance of award. Should the successful bidder fail to accept the award, the bid bond check shall be forfeited.

The City follows a policy of nondiscrimination. No contractor with the City should discriminate on the basis of race, sex, religion or national origin. Failure by the Vendor to carry out these requirements is a material breach of its obligations, which may result in its termination or such other remedy as the City deems appropriate. No bid may be withdrawn for a period of sixty (60) days after the date of the bid opening.

All bids are to be submitted on the bid form provided and all bids are to be f.o.b. Birmingham, Alabama delivered. The City reserves the right to reject any or all bids submitted, in whole or part, and to waive any informalities.

**GENERAL**

The City of Birmingham is seeking bids for a contract for “mobile equipment tires” for its fleet of mobile equipment. The basis of the bid shall consist primarily of any and all tires and tire repair service as may be required by the City of Birmingham. The City intends to award this contract to the lowest priced, responsive, responsible bidder.

**CANCELLATION**

The City reserves the right to cancel the contract, in whole or part, and seek new bids at any time the City determines that the services, item(s) and/or product lines(s) being supplied is/are failing to perform satisfactorily. Any bid that imposes a service fee or any other type of fee on any order not exceeding a minimum order quantity or minimum purchase order dollar amount, will be determined a non-responsive bid and will not be considered for award. Municipalities are not liable for sales tax: reference Code of Alabama Section 40-23-4. Costs normally considered pass through costs (property tax, use tax, delivery charge, etc.) to the customer by the provider must be included in any fee proposed (Code of Alabama 40-12-222.) For the purchase of personal property, the City’s policy is to apply a local preference option, as allowed by the State of Alabama Code, Section 41-16-50, in determining the low bidder. The contract shall become effective from the date of the Notification of Award letter which will be mailed to the successful bidder.

**PURCHASE ORDERS**

The City will issue purchase order(s) to the successful bidder for the goods and/or services (bid items) that are the subject of the bid. Unless otherwise agreed in a writing that is signed by both parties, the entire agreement between the City and the successful bidder concerning the bid items is comprised of the terms, conditions, specifications and requirements stated in (a) the contemplated purchase order(s), (b) this Invitation to Bid and Specifications and (c) your bid (collectively, the “Contract Requirements”). These writings supersede all former proposals, offers, negotiations, representations or agreements, either written or oral, concerning the provision of vendor’s goods and/or services. By acceptance of the City’s purchase order(s), the successful vendor agrees to abide by and perform its responsibilities related to the bid items in compliance with the Contract Requirements.

Successful bidder shall not assign this contract to any other party without prior written approval of the City of Birmingham. Contract shall not be assigned to an unsuccessful bidder who was rejected because he was not a responsive or responsible bidder.

**TERMINATION OF CONTRACT**

Failure to adhere to any or all terms, conditions and specifications as set forth in the contract may result in the immediate termination of the contract. Should termination occur, the holder of the contract may be declared a “non-responsible vendor” This declaration may result in the rejection of any future bids submitted by the vendor for a period of time to be determined by the City.

All bids submitted are to be F.O.B. delivered, City of Birmingham, Birmingham AL 35203.

**PRICES**

Include transportation (including fuel surcharge, if applicable)

**QUANTITIES**

The quantities shown on the bid form are estimated quantities only. Merchandise shall be ordered as requirements dictate. The City reserves the right to purchase more or less than this quantity as conditions require, and no bidder shall attempt to hold the quantities shown as a firm quantity under this contract.

**PRE-PAYMENTS**

No prepayments of any kind will be made prior to shipment.

**TAX**

The City of Birmingham is exempt from all Federal Tax, and sales and use tax, except Alabama tax on oils, lubricants and fuels specifically bought for over-the-road transportation use.

**ADDITIONAL PURCHASES**

The City has attempted to list all items required for “Mobile Equipment Tires”, required during the term of the contract, if mutually agreed upon, additional contracts may be executed, based upon this bid for the same item(s) or related types and/or sizes.

**REDUCTION IN COST**

Bidder agrees that the City of Birmingham will be charged no more for item(s) bid than the State of Alabama, and that in the event of a price reduction; the City will receive the benefit of such reduction on any undelivered portion of contract.

**Successful bidder acknowledges and agrees that the City has the right to deduct from total amount of consideration to be paid, if any, to the successful bidder under this agreement all unpaid, delinquent, or overdue license fees, taxes, fines, penalties, and other amounts due the City from the successful bidder.**

**NON- DISCRIMINATION POLICY**

Vendor (and its employees, agents and any subcontractors) shall not discriminate on the basis of race, color, sex, gender identity, sexual orientation, disability, familial status, or national origin in the performance of the services contemplated hereunder. Failure by the bidder to carry out these requirements is a material breach of its obligations which may result in its termination or such other remedy as the City deems appropriate.

**DISADVANTAGED BUSINESS ENTERPRISE (DBE)**

Vendor acknowledges and agrees that, consistent with federal law and City’s public policy, it will encourage disadvantaged business enterprise (DBE) participation to the extent permitted by law. A “disadvantaged business enterprise” is a for-profit small business concern (i) at least 51% owned by one or more individuals who are both socially and economically disadvantaged or, in the case of a corporation, in which 51% of the stock is owned by one or more such individuals; and (ii) whose management and daily business operations are controlled by one or more of the socially and economically disadvantaged individuals who own it. In accordance with federal law, a “socially and economically disadvantaged individual” includes African-Americans, Hispanic Americans, Native Americans, Asian-Americans, women, and any additional groups designated as socially and economically disadvantaged by the federal Small Business Administration.

**FORM W-9**

Any successful bidder who is not currently set up as a vendor in the City of Birmingham vendor file will be required to submit a completed W-9 tax form prior to any award. The W-9 tax form may be submitted with your bid or no later than seven (7) working days of receipt of notice of intent to award.

**BUSINESS LICENSE**

The City of Birmingham must have a copy of the successful bidder’s current City of Birmingham business license prior to formal award of contract. A copy of his/her license may be submitted along with his/her bid. In the event you receive a notification of intent to award letter, bidder must provide a copy of his/her current business license no later than seven (7) working days of receipt. Failure to submit the requested information will result in the notice of intent to award being revoked.

**PUBLIC DISCLOSURE**

Subject to applicable law or regulations, the content of each Bidder’s Proposal shall become public information upon the effective date of any resulting contract.

**TELEGRAPHIC/ELECTRONIC BID RESPONSES**

Proposal responses sent by electronic devices (i.e., facsimile machines and email) are not acceptable and will be rejected upon receipt. Vendors will be expected to allow adequate time for delivery of their bid responses either by airfreight, postal services, or by other means.

**E-VERIFY**

Successful Vendor (located in the State of Alabama or located outside of the State of Alabama, but employs one or more employees within the State of Alabama) represents and warrants that it does not knowingly employ, hire for employment, or continue to employ an "unauthorized alien", as defined by the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, Act No. 2011-535 (H.B.56) of the Alabama Legislature, as amended from time to time (the "Act") and that, during the performance of this contract, Vendor shall participate in the E-Verify program as required under the term of the Act. Vendor agrees to comply with all applicable provisions of the Act. As a condition for the award of any contract, Vendor shall provide documentation establishing that the Vendor is enrolled in the E-Verify program, or a signed, written statement that the Vendor does not have a presence (one or more employees) in the State of Alabama. Vendor may submit applicable documentation with his/her bid or no later than seven (7) working days of receipt of notice of intent to award.

**Bids may be solicited for the product included in this contract where an immediate/ emergency need exists including large quantities. The decision of the Purchasing Agent as to what constitutes a biddable situation shall be final and shall not be construed as a breach of contract. **SINGLE BID**

If a single bid response is received for this ITB, the bid will be rejected in accordance with Title 41-16-50-a of the Alabama Code. The bid will be opened but **will not** be read publicly. We will proceed with negotiations for a lower price with the rejected Bidder and other Bidders by means of sealed quotes. The rejected Bidder's initial offer will not be disclosed to other Bidders, prior to the awarding of a contract. The award will be made to the company offering the lowest negotiated quotation, provided that all conditions and specifications required by the City are met.

**NEGOTIATIONS**

The City of Birmingham reserves the right to enter into contract negotiations with the selected Bidder. If the City and the selected Bidder cannot negotiate a successful contract, the City may terminate negotiations and begin negotiation with the next selected Bidder. This process will continue until a contract has been executed or all proposals have been rejected. No Bidder shall have any rights against the City arising from such negotiations.

**PROHIBITION AGAINST BOYCOTTING**

By signing this contract, the Contractor certifies that it is not currently engaged in, and for the duration of this agreement will not engage in, the boycott of a person or an entity based in or doing business with a jurisdiction with which this state enjoys open trade.

**AWARD**

Bidders may quote any or all groups of interest. **Bidders are not required to bid every group in order to be eligible for award(s).** Contract will be awarded to the lowest most responsive and responsible bidder(s) who meets all bid requirements and has a history of successfully completing like work.

**GOVERNING LAW/DISPUTE RESOLUTION**

Contract award to purchase the materials covered in this bid document shall be construed under and governed by the laws of the State of Alabama and each party hereto irrevocably agrees to be subject to the jurisdictions of the courts of the State of Alabama.

**PAYMENT TERMS**

The City's standard payment term is Net-30 days from acceptance. Exception may be allowed for discounted early payment, such as 2%-10, Net 30 Days. The reference date for all such discounted early payment terms will be the date the invoice is received or the date the goods are received, whichever is later. In the event of a dispute the City's records shall prevail. **The City will not consider any bids requiring C.O.D. payments.**

**STATEMENT OF COMPLIANCE WITH ALABAMA CODE SECTION 31-13-9**

Vendor shall participate in the E-Verify program as required under the Beason-Hammon Alabama Taxpayer and Citizen Protection Act. Vendor agrees to comply with all applicable provisions of the Act. As a condition for the award of any contract, Vendor shall provide documentation establishing that the Vendor is enrolled in the E-Verify program, or a signed, written statement that the Vendor does not have a presence (one or more employees) in the State of Alabama. **HOLD HARMLESS AND INDEMNIFICATION**

Vendor(s) shall defend, indemnify, and hold harmless the City of Birmingham, and its agents, employees and officials (hereinafter the "Indemnitees") from and against all demands, actions, damages, judgments, expenses (including but not limited to attorneys' fees, expert fees, court costs and other litigation costs), losses, and claims (including those for bodily injury, sickness, disease or death, or to injury to, destruction or loss of use of tangible property) (collectively hereinafter "Claims") by any third parties (including any employee, subcontractor or representative of the Vendor, hereafter a "Vendor Representative") that arises out of, relates to, results from, or is attributable to any of the following: (a) Vendor's performance or failure to perform its obligations hereunder; (b) any conditions in or about the work sites that the Vendor or any Vendor Representative may encounter; or (c) the use or occupancy of the work sites by Vendor or any Vendor Representatives. This indemnification obligation includes Claims that are caused in part by the negligence of an Indemnitee(s); provided nothing herein shall obligate Vendor to indemnify any of the Indemnitee(s) for Claims resulting from the sole negligence or from the willful misconduct of the Indemnitee(s).

**NON-COLLUSION**

Contractor covenants and declares that it has not employed any person to solicit or procure this Agreement and that Contractor has not made, and will not make, any payment of any compensation for the procurement of this Agreement. The covenant contained herein shall survive the expiration or earlier termination of this Agreement.

**CONFLICT OF INTEREST**

Contractor covenants and declares that it has not, and will not, acquire any interest, directly or indirectly, in any property acquired by the City during the term of this Agreement. Contractor warrants and covenants that it presently has no interest in, nor shall any interest be hereinafter acquired in, any matter that will render the services required under this Agreement a violation of any applicable Federal, State or local law. In the event that any conflict of interest should hereinafter arise, Contractor shall promptly notify the City in writing of the existence of such conflict of interest.

**CONFIDENTIALITY**

Contractor agrees that such reports, information, opinions or conclusions shall not be made available to or discussed with any individual or organization, including the news media, without prior written approval of the City. Contractor shall exercise reasonable precautions to prevent the unauthorized disclosure and use of the City information whether deemed confidential or not

If an invoice does not agree with the purchase order, credits or a corrected invoice will be required in order for the City to process payment.

**THIRD-PARTY "REMIT-TO"**

If a Bidder has a third-party "remit-to" company, that information must appear on the Bidders response. The City of Birmingham will send payment to the company designated by the Bidder on its response but will not be responsible for resolving payment issues should the Bidder change payment processing companies after a payment has been mailed or without a 45-day written notification to the BPD and Accounting Division of the City of Birmingham.

**SPECIFICATIONS FOR NEW MOBILE EQUIPMENT TIRES**

Awards will be made only for premium grade, first (1<sup>st</sup>) line tires. Tires offered and furnished are to be nationally recognized as a quality level tire meeting or exceeding the Original Equipment (OE) tire that was mounted on the equipment when sold by the original equipment manufacturer. The tires must be listed in the manufacturer's regular published State Net Price List that is to be submitted with the bid. No promotional, economy, special produced, second (2<sup>nd</sup>) tier tires, blemished, unlisted and/or special listed tires will be eligible for consideration.

All tires are to be of current production and must carry all markings currently required by the Federal Government at the time of shipment and must be in compliance with all applicable regulations. All tires bid shall be at a minimum equivalent to those manufactured as original equipment for domestic autos and light/medium & commercial trucks.

Flaps are to be included with any tube type tire the City may purchase during the life of the contract. All tires quoted as a "pursuit" tire shall be of radial construction and of a high speed stability design providing protection against high speed blowout and chunk-out. The tire must have been tested and approved for "pursuit" tire applications. Bidder is to include with the bid documentation from the manufacturer substantiating the approval. The sixteen (16) inch pursuit tire must have a speed rating of no less than "V" and the seventeen (17) and eighteen (18) inch pursuit tire no less than a "W" rating. The City acknowledges that some manufacturers provide the pursuit tires only in a directional tread design, however, for practical purposes the City's preference is for a non-directional tread design. Bidders are to bid only tires of a non-directional design.

All radial medium/commercial truck tires will carry a minimum of a two (2) year carcass warranty for the purpose of recapping.

**DETAILED REQUIREMENTS & SPECIFICATIONS**

Bidders must attach a copy of the manufacturer's warranty applying to **all** tires offered the City. Warranty information must include protection against defective material, workmanship and failure to perform in accordance with required performance criteria.

Prices quoted are to be F.O.B. delivered, City of Birmingham, Municipal Garage - Tire Shop, 515 6<sup>th</sup> Avenue South, Birmingham, AL 35205. All associated delivery costs are to be calculated into the prices quoted. **No delivery surcharges of any nature will be allowed.**

Bidder must be an authorized stocking distributor for any product line offered to the City for consideration.

Consideration will be given to service and distribution facilities. The successful bidder(s) shall be required to maintain an adequate inventory and delivery service to properly service the City as its requirements demand. The City reserves the right to inspect any potential vendor's equipment, inventories, personnel, locations etc., to verify that potential vendor has the ability to properly service the City's requirements before any award is made.

The City has limited storage space. Prompt delivery shall be an essential requirement for each of the Groups. **For Group's 1, 2, & 3** the City will place inventory orders on a day to be agreed upon with the successful vendor(s) each week. Delivery of these Group's inventory orders should be no later than 2:30 p.m. the following day. Emergency orders should be delivered within a four (4) hour time period. Back-orders should be delivered no later than five (5) working days after order was placed.

Each bid for **Groups 1, 2, & 3** must have attached a statement of certification by an authorized official of the manufacturer of the tires offered the City, to the effect that said manufacturer endorses the proposal made to the City, and that said proposal is in accordance with these specifications; also, that the manufacturer will be responsible for the performance of any contract entered into as a result of said proposal. This certification must be signed by an official representing the manufacturer with an executive capacity of no less than Vice-President of said manufacturer.

**For Group's 4 & 5** the City will place inventory orders weekly on a day to be agreed upon with the successful vendor(s).

Delivery of these Group's orders should be no later than two (2) working days following order placement. Emergency orders should be delivered within one (1) day of order placement. Back-orders should be delivered no later than seven (7) working days after the order was placed.

The failure to deliver orders for any Group in a consistent manner will constitute grounds for the termination of this contract and the declaration of the vendor as a "non-responsible vendor", which will result in the rejection of any future bids submitted by the vendor.

**BRANDING REQUIREMENT**

All tires in **Group 3 (Medium/Commercial Truck)** are to be branded with the initials, "COB" in one inch (1") high letters in white ink on one side of the tire sidewall before delivery to the City. The successful bidder shall be required to furnish the branding iron. Bidder shall indicate the cost of such branding in the space provided on the Bid Form and the price quoted shall remain in effect for the life of the contract. **The price quoted will be a consideration of award.**

**PRICING STRUCTURE**

Due to the impracticality of listing each and every size, grade level, and performance level within the same tire size, all bidders shall quote this bid invitation with written assurance to the City that any and all tires, within a group, that are not shown in the size and type charts of the Bid Form shall be furnished to the City of Birmingham at the same rate of discount as shown on the tires so quoted.

Each bidder when quoting shall furnish with the bid, the manufacturer's "Net State Price List" covering all the tires being offered the City for consideration. The price list must show the current Net State price and the effective dates. If the manufacturer bid has no Net State Price List, a Wholesale Price List may be submitted. Any price list submitted must include **all** of the manufacturer's available tire grades and sizes within the particular group being quoted. Bidders are to indicate in the spaces provided on the Bid Form, any discount rate that will apply to the submitted price sheets. **These price sheets combined with any stated discount rate will be used to determine the City's price for any and all tires not shown on the Bid Form.** Discount rate is to be a **fixed, flat rate** for each tire group specified. **Do not quote discount ranges for a tire group (ex: Passenger Car Tires: 30 – 50%)**. In the case of Light Truck/SUV tires where there may be an overlap of tires classed as light truck and/or passenger car, bidders may quote two flat rates of discount if different rates apply.

**PRICING STRUCTURE(CONT'D)**

Failure to provide price sheets with the bid could result in the outright rejection of the bid from consideration.

While the City's preference is that one manufacturer cover an entire group, the City realizes that in some cases vendors may be required to offer more than one manufacturer's product lines in order to completely quote the group. The City will accept any such bid as reasonable. Bidders **must** include price sheets from **all** manufacturers quoted and state applicable discount rate for each manufacturer's price sheets submitted.

**City Additional Named Insured:** Except for Worker's Compensation coverage, all coverages shall contain endorsements naming the City, and its officers, employees and agents as additional insured with respect to liabilities that arise out of and result from the operations of the Contractor or the performance of its work.

The additional named insured endorsement shall not limit the scope of coverage to the City to vicarious liability but shall allow coverage for the City to the fullest extent provided by the policies. Such additional insured coverage shall be at least as broad as Additional Insured endorsement from ISO, CG 2010.1185.

**Policies Primary:** All insurance policies required herein are to be primary and non-contributory with any insurance or self-insurance program administered by the City.

**Waiver of Subrogation:** Contractor shall require the carriers of the above required insurance coverage to waive all rights of subrogation against the City, and its officers, employees, agents, contractors and subcontractors. Further, Contractor hereby waives any rights of subrogation against the City. All general or automotive liability coverage provided herein shall not prohibit the Contractor or its employees, agents, or representatives from waiving the right of subrogation prior to loss or claim.
