("UAHSF"), in substantially the same form as on file in the Office of the City Clerk and as before this Council, in response to RFP# 25-04, under which UAHSF will provide pre-employment physicals, drug screen and alcohol testing, care for non-emergent on the job injuries, vaccination services, and other tests assigned by the City's Director of Human Resources from time to time, for a term of three (3) years at Two Hundred Fifty Thousand and No1100 Dollars (\$250,000.00) per year, for a total amount not to exceed Seven Hundred Fifty Thousand and No/100 Dollars (\$750,000.00).
