#### **Welcome and Introductory Items**

Advisory Group Chair Paul Beaumaster called the meeting to order. Roundtable introductions were made. Beaumaster announced the retirement of Mark Ostrem, Advisory Group member representing the Minnesota County Attorneys Association. A quorum was not present, so approval of the November 2024 minutes could not be voted on.

#### **BCA Fusion Center Overview and Tour**

Assistant Special Agent in Charge/Fusion Center Deputy Director Tom Roth presented an overview of the Minnesota Fusion Center. The MNFC is comprised of both sworn and civilian staff to collect, evaluate, analyze and disseminate information throughout Minnesota and nationally. The MNFC works as a partnership with government, law enforcement, public safety and the private sector to protect homeland security.

Criminal Intelligence Analyst Rick Langan presented on the Threat Liaison Officer program, which is a training program available to any sworn or unsworn law enforcement, emergency service personnel, military, public health professional, private, nonprofit or other public sector employee with a role in the security in their respective discipline. Threat Liaison Officer Basic Training, a new training course driven by the Fusion Center, will certify the above mentioned people group to be a Threat Liaison Officer with the MNFC and partner agencies.

ASAIC Roth finished the presentation with a tour of the newly completed Fusion Center.

#### **Advisory Group Bylaws Updates**

Diane Bartell provided an overview of intended changes to the Advisory Group bylaws, which included the updated name change and updated terminology to reflect the 2024 statute update. The group discussed how to gain more members, specifically more diverse members. Dana Gotz asked the members to consider a curated, diverse list of suggestions and recommendations created by a Diversity subcommittee, chaired by Advisory Group member Barbara Carson. Discussion of further changes to the bylaws will be tabled to the next meeting.

#### **Legislative and BCA Updates**

Superintendent Evans provided updates on previously mentioned legislative proposals. Two proposals being pushed through the current session include updating the Unmanned Aerial Vehicle law to include use during police pursuits, and banning childlike sex dolls and Al-generated Child Sexual Abuse Material.

In addition, Evans reinforced that all bodycam-worn and other video footage is not physically able to be posted publicly within 30 days of Use of Force incidents on the BCA website due to the volume of video and the time it takes to review and redact. BCA is requesting for authority to limit the scope of the extraneous video that is required to be posted within 30 days to only the specific event, while not changing data classification.

Evans asked for funding to develop a more robust, real-time, Minnesota-specific Missing Persons database to include trends and categories helpful to Minnesota law enforcement. He also mentioned the new BCA Financial Crimes and Fraud Section that transferred the previous Commerce Fraud Bureau to the BCA through a Governor's Executive Order and subsequent Dept. of Administration Reorganization Order effective February 7, 2025. The BCA is asking for 3 FTEs in the Governor's budget for forensic accounting and prosecutorial support.

Evans stated that he continues to advocate for dedicated program administration support for the Advisory Group.
