



2024-2026 ARMER Equipment Grant Program Application and Award Summary

October 8, 2024

Grant Overview and RFP Response

The Department of Public Safety, Emergency Communication Networks division (DPS-ECN) requests proposals to the 2024-2026 Allied Radio Matrix for Emergency Response (ARMER) Equipment Grant Program. Through this grant program, DPS-ECN provides grant funding to support the purchase and upgrade of radio equipment for local, Tribal, and state agencies participating in the ARMER radio system.

DPS-ECN solicited for this grant with a grant request for proposals (RFP) in the second quarter of 2024 and completed scoring and evaluation through the following August and September. The program received a high interest from applicants, with total requests for funding far exceeding the \$4 million in funds available. In total, 178 entities applied to this grant with projects totaling over \$23 million in requested grant funds and an average grant funding request of \$130,000.

Grant Award Priorities and Considerations

A review panel was established by DPS-ECN consisting of internal and external stakeholders and ARMER subject matter experts to score and recommend awards for this grant. 77 applications were ultimately selected for funding, with an average award of \$51,000. Ineligible applicants (applicants who are not state agencies, local units of government, or federally recognized Tribes), proposals for ineligible projects or purchases, and late or incomplete applications were eliminated from the review pool. Entities which submitted more than one application could not be awarded more than one grant award, and awards were made to the highest scoring individual application from such agencies.

Priorities and funding decisions for this grant program are based on the following factors:

- A preference for making more awards at lower grant award amounts over few awards at higher award amounts.
- Higher scores given to applicants who could demonstrate:
 - A high ratio of failing or failed equipment compared to current need, or who were not meeting current ARMER system requirements.
 - A need specifically for radio subscriber equipment and accessories, although other equipment requests were considered based on needs identified by the applicant.
 - Evidence that little to no resources were available to fill the same operational purpose.
 - Strong collaboration efforts and interoperability planning for the purchase, installation, and maintenance of the equipment.
 - A commitment to providing matching funds.
- The highest-scoring applications were awarded until no more awards could be made. The remaining balance of the grant award was added to the highest-scoring applicant.



- Applications were scored based on a 100-point scale, established in the grant RFP. An adjustment up or down from the estimated \$40,000 average award was made based on score:
 - Collaborative applicants (applications that indicated sub-awards to one or more additional unique entities) received a multiplier to their award amount based on number of sub-award entities.
 - Applicants scoring 90-100 on their consolidated score were awarded \$50,000 or their maximum award, whichever was lower.
 - Applicants scoring 80-89 on their consolidated score were awarded \$40,000 or their maximum award, whichever was lower.
 - Applicants scoring 79 or less were awarded \$30,000 or their maximum award, whichever is lower, from the highest to the lowest score until no more awards could be made.

A complete list of grant requests, scores, and award decisions are provided as an attachment to this document. Scores are sorted from highest score to lowest (the farthest right-hand column), the blue columns representing award requests and green representing the awarded amounts.
