

FWA Jackpot Getaway Official Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who sign up on the giveaway web page: [FWA Jackpot Getaway | Fort Wayne Airport Authority](#) and who are 21 years of age or older as of the date of entry. The Campaign is only open to legal residents of the United States, and is void where prohibited by law. Employees of the Fort Wayne-Allen County Airport Authority (“Sponsor”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. Campaign Period: Entries will be accepted online starting at 3PM EST on Tuesday, September 1, 2026 and ending at 11:59PM EST on Wednesday, September 16, 2026. Winner will be announced at 12PM EST on Thursday, September 17, 2026.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Sponsor. You may enter only once. You must provide the information requested. You may

The Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Rules.
