

End-User License Agreement (EULA)

This End-User License Agreement ("EULA") is a legal agreement between you ("User" or "you") and StockDreams LLC ("we," "us," or "our") regarding your use of the DreamsBets Discord server ("DreamsBets" or the "Service"). By accessing and using DreamsBets, you agree to be bound by the terms and conditions of this EULA. If you do not agree to these terms, you may not use the Service.

1. **Grant of License** Subject to your compliance with the terms and conditions of this EULA, we grant you a limited, non-exclusive, non-transferable, revocable license to use DreamsBets for personal and non-commercial purposes. This license does not grant you any ownership rights or intellectual property rights in DreamsBets.
2. **User Responsibilities**
 - 2.1 **Eligibility** You must be at least 18 years old to use DreamsBets. By accessing and using the Service, you represent and warrant that you are at least 18 years old and that you have the legal capacity to enter into this EULA.

2.2 **Compliance with Laws** You agree to use DreamsBets in compliance with all applicable laws, rules, and regulations. You shall not engage in any illegal, unauthorized, or fraudulent activity while using the Service.

2.3 **User Conduct** You agree to use DreamsBets in a manner that is respectful of other users and consistent with the purpose of the Service. You shall not:

- Post, transmit, or share any content that is unlawful, defamatory, abusive, offensive, obscene, or infringing upon the rights of others.
 - Harass, threaten, or intimidate other users or interfere with their use and enjoyment of the Service.
 - Attempt to gain unauthorized access to the Service or any user accounts, or disrupt or interfere with the security of the Service or its systems.
 - Use the Service to advertise or promote any products, services, or other websites without our prior written consent.
3. **Intellectual Property** All intellectual property rights in DreamsBets, including but not limited to trademarks, logos, and content, are owned by or licensed to StockDreams LLC. You shall not modify, reproduce, distribute, or create derivative works based on DreamsBets without our prior written permission.

4. Termination We reserve the right to terminate or suspend your access to DreamsBets at any time and for any reason without prior notice. Upon termination, you shall immediately cease all use of the Service.
5. Limitation of Liability TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL STOCKDREAMS LLC, ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, OR AFFILIATES BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF OR IN CONNECTION WITH YOUR USE OF DREAMSBETS, WHETHER BASED ON CONTRACT, TORT, NEGLIGENCE, STRICT LIABILITY, OR OTHERWISE.

Indemnification You agree to indemnify, defend, and hold harmless StockDreams LLC, its directors, officers, employees, agents, and affiliates from and against any claims, liabilities, damages, losses, costs, or expenses, including reasonable attorneys' fees, arising out of or in connection with your use of DreamsBets or your breach of this EULA.
7. Modifications to the EULA We reserve the right to modify or update this EULA at any time. Any changes will be effective immediately upon posting the updated EULA on DreamsBets or by other means of communication. Your continued use of DreamsBets after the modifications indicate your acceptance of the revised EULA.
