

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 14431 VENTURA BLVD, and Helix Software LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Helix Software LLC include 14431 VENTURA BLVD and Helix. The Helix website is a Consultation site. By using the Helix website, you consent to the data practices described in this statement.

Collection of your Personal Information
