

Terms & Conditions

Please read these Terms and Conditions ("Terms") carefully before accessing or using the BezosProxy service ("Service") provided by bezosproxies Limited Liability Company ("Company") through the website bezosproxy.com or any other means ("Website"). These Terms constitute a legally binding agreement between you ("User") and the Company.

1. Acceptance of Terms By accessing or using the Service, the User agrees to be bound by these Terms, including any additional guidelines, policies, or rules provided by the Company. If the User does not agree to these Terms, they should not access or use the Service.

2. The User agrees to submit to the exclusive jurisdiction of the state and federal courts located in the State of Virginia for the resolution of any disputes arising out of or related to these Terms or the Service.

12. Severability If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions shall continue to be valid and enforceable to the fullest extent permitted by law.

13. Entire Agreement These Terms constitute the entire agreement between the User and the Company regarding the Service and supersede all prior or contemporaneous agreements, communications, and proposals, whether oral or written, between the User and the Company.
