

End-User License Agreement (EULA) for F2P (Flip 2 Profit)

IMPORTANT NOTICE:

This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and F2P (Flip 2 Profit) ("F2P," "we," "us," or "our") for the digital content, services, features, and functionalities provided via our platform.
