

Mazi Picks Terms of Service Agreement

1. Acceptance of Terms

By purchasing access to Mazi Picks, you agree to be bound by these Terms of Service (the "Terms"). If you do not agree to these Terms, do not purchase or use Mazi Picks services.

2. Eligibility
