

GOLD SQUAD INC. DISCORD TERMS OF SERVICE & USE

Upon joining the Gold Squad Discord server, you agree to abide by the following terms of use and terms of service.

1. Legal Entities

Ownership: Gold Squad Inc. owns and controls 100% of the Gold Squad Discord server & community.

Partnership: Gold Squad Inc. operates the Gold Squad VIP membership through Whop Inc., but is not responsible for Whop Inc.'s actions or operations.

Founders: Gold Squad Inc. was established by CryptoMason Inc. and Megbzk Inc., owned respectively by Mason Versluis and Meghan Boyczuk.

2. Gold Squad VIP Membership

Right to Ban: We reserve the right to ban any VIP member for violations of our rules.

Refunds: Refunds for VIP memberships are only granted under circumstances that we find justifiable. No refunds will be given for failures to cancel or turn off auto-renewal.

Auto-Renewal: By default, VIP memberships automatically renew, similar to subscriptions like Netflix or Amazon. It is your responsibility to cancel.
