

TERMS OF SERVICE

Rios LLC (also known as Frugal Season) does not offer refunds to any user under any circumstances outside our refund policy and by purchasing a membership to our service, you agree that all payments collected from you are irreversible and you will not attempt to seek a refund via chargebacks. By buying or redeeming a subscription, you agree to be charged \$75 on a monthly renewal basis. Frugal season reserves the right to revoke your access to your membership for any reason at any given time, and by purchasing a membership you acknowledge that your membership can be revoked whether or not your membership purchase falls in the exclusions stated in these terms.
