

Privacy Policy for The DJ Collective

At The DJ Collective ("Company," "We," "Our," or "Us"), we prioritize your privacy and are committed to protecting your personal information. This Privacy Policy explains how we collect, use, disclose, and safeguard your data when you subscribe to and use our service through Whop, including access to our Discord community and associated features (collectively, the "Service"). By subscribing to and using our Service, you agree to the practices described in this policy.

1. Information We Collect

1.1 Personal Information:

- **Subscription Information:** When you subscribe to our Service via Whop, we collect personal information such as your name, email address, payment details, and subscription preferences.

2.3 Analytics:

3.1 With Whop:

- **Payment Processing:** Your payment details are processed by Whop, which has its own privacy policy governing how your information is handled. We do not store or process payment information directly.
