



i Juske FX Terms of Service

Welcome to Juske FX. By accessing or using our services, including but not limited to our website, social media platforms, paid educational courses, and any other Juske FX content, you agree to comply with the following Terms of Service. Please read these terms carefully.

- Master Courses ("Meistro Kursai"): €1,199.99 per unauthorized viewer.
- Forex Startup ("Forex Pradžiamokslis"): €239.99 per unauthorized viewer.

For example, if a shared course video is viewed 10 times, the responsible party will be charged 10 times the cost of the respective course. These amounts will be subject to enforcement through legal action if necessary.

We reserve the right to pursue any and all legal actions against individuals or entities that engage in the unauthorized use, reproduction, or distribution of Juske FX intellectual property. This includes, but is not limited to, seeking compensatory damages, legal costs, and the full penalty fees outlined above.
