

# MTMVERSE End User License Agreement (EULA)

**Effective Date: January 1, 2024**

This **End User License Agreement** (the “Agreement” or “EULA”) is a legal contract between you (the “User” or “Subscriber”) and **MTMVERSE** (“we,” “us,” or “our”) regarding your use of our subscription-based platform, services, and educational content, including time-sensitive alerts, training materials, and other resources (the “Services”). By accessing, subscribing to, or using our Services, you agree to be bound by the terms of this Agreement.

If you do not agree to the terms outlined in this Agreement, you should not subscribe to or use the Services.

## 1. License Grant

This Agreement will be governed by and construed in accordance with the laws of the jurisdiction in which **MTMVERSE** is based, without regard to its conflict of law principles. Any disputes arising from this Agreement shall be resolved in the courts located within the applicable jurisdiction.
