Protecting your private information is our priority. This Statement of Privacy applies to Scarface Trades LTD and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Scarface Trades LTD

The Scarface Trades website is an educational platform. By using the Scarface Trades Whop, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Scarface Trades may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Scarface Trades' products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Scarface Trades' public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include:

- Registering for an account
- Entering a sweepstakes or contest sponsored by us or one of our partners
- Signing up for special offers from selected third parties
- Sending us an email message
- Submitting your credit card or other payment information when ordering and purchasing products and services

To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We may also gather additional personal or non-personal information in the future.

Use of your Personal Information

Scarface Trades collects and uses your personal information to operate and deliver the services you have requested.

Scarface Trades may also use your personally identifiable information to inform you of other products or services available from Scarface Trades and its affiliates.

Sharing Information with Third Parties

Scarface Trades does not sell, rent, or lease its customer lists to third parties.

Scarface Trades may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Scarface Trades may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Scarface Trades, and they are required to maintain the confidentiality of your information.

Scarface Trades may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to:

Tracking User Behavior

Automatically Collected Information

Right to Deletion

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity
- Debug to identify and repair errors that impair existing intended functionality
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law
- Comply with the Canadian Electronic Communications Privacy Act
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us
- Comply with an existing legal obligation

- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information
