

Blazen Trade - Privacy Policy

Effective Date: February 8th, 2022

At **Blazen Trade**, we are committed to protecting your privacy and ensuring a safe and secure environment for all users. This Privacy Policy outlines the types of information we may collect from you, how that information is used, and the steps we take to safeguard your data. By using our Discord server, you agree to the practices outlined in this Privacy Policy.

1. Information We Collect

When you interact with **Blazen Trade**, we may collect the following types of information:

- **Discord Username and ID**: When you join the server, your Discord username and unique Discord user ID are automatically available to us.
- **Messages and Content**: Any messages, media, or content you post in the server may be collected by the administrators and moderators.
- **Activity Logs**: We may track your activity within the server, including your participation in channels, trades, and other interactions.
- **Server Interaction**: We may collect information on how you interact with bots, roles, or other server features, including whether or not you use particular server commands.

Note: We do not collect or store any sensitive personal data, such as your real name, email address, or financial information, unless voluntarily provided by you for a specific purpose (such as participating in a survey or feedback form).

2. How We Use Your Information

We use the information collected to:

- **Administer and Moderate the Server**: To manage roles, permissions, and maintain the integrity of the community.
- **Provide Services**: To enable the trading and interaction features within **Blazen Trade**, ensuring a functional and enjoyable user experience.
- **Improve the Server**: To analyze server activity and improve the content, structure, and functionality of **Blazen Trade**.
- **Enforce Server Rules**: To ensure compliance with our Code of Conduct and Terms of Service and prevent any inappropriate or harmful behavior.
- **Communication**: We may use your information to notify you about updates, changes to server rules, or other relevant information regarding the server.

3. Data Security

We take the protection of your data seriously. However, please note that no method of transmission over the Internet or method of electronic storage is 100% secure. While we strive to protect your personal information, we cannot guarantee absolute security. We encourage you to be cautious with any personal or sensitive information you share.

4. Third-Party Services

Blazen Trade is hosted on **Discord**, which has its own privacy policy. We encourage you to review the Discord Privacy Policy, as we are subject to its terms when you use our server. However, **Blazen Trade** does not share your data with any third-party services outside of Discord unless explicitly stated.

- **Bots**: Some bots may collect user data for their own functionality (e.g., role assignments, stats tracking). These bots are subject to their own privacy policies, and we advise you to review the specific privacy policies of any bots you interact with in the server.
- **External Links**: If the server includes any links to third-party websites or external resources, we are not responsible for the privacy practices of those sites. We encourage you to read the privacy policies of those sites before providing any personal information.

5. Data Retention

We retain your data for as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by law. If you leave the server, your data (such as your messages and content) may still be retained in the server's logs, though we do not intentionally retain personal information after your departure unless required for legal reasons.

6. Your Rights and Choices

As a user of **Blazen Trade**, you have the following rights regarding your data:

- **Access and Correction**: You may request access to the information we hold about you and request corrections if it is inaccurate.
- **Data Deletion**: You may request that we delete your data. However, please note that some data (e.g., messages you've posted) may be retained as part of our server's activity logs, even after you leave the server.
