

## Refund Policy

Effective Date: December 30, 2024

The adjudication of such grievances remains within the exclusive purview of the Company, with discretionary authority over procedural transparency.

3.2 Evidentiary Burden of Claimant: The initiation of any refund consideration process necessitates the submission of exhaustive, substantiated, and incontrovertible documentation by the claimant, which shall be subjected to comprehensive internal scrutiny under an undefined temporal framework.
