

Pokenotify End-User License Agreement (EULA)

Effective Date: 11/01/2024

This End-User License Agreement (“Agreement”) is a legal contract between you (“User”) and **PokeNotify** (“we,” “us,” or “our”) that governs your use of our services, software, and digital content (collectively referred to as the “Service”).
