

## END USER LICENSE AGREEMENT (EULA)

**This End User License Agreement (“Agreement”) is a legal agreement between you (“User”) and Go Getter Star LLC (“Company”), governing the use of all software, content, digital products, and services provided by Go Getter Star LLC (collectively, the “Services”). ### 1. LICENSE GRANT
