Discord Community — Terms of Service

Effective Date: May 30 2025

1. Acceptance of Terms

By purchasing or accessing any subscription that grants entry to the Blockchain Bureau Academy (“**BBA**,” “**we**,” “**our**”) Discord server (the “**Community**”), you (“**User**,” “**you**”) agree to be legally bound by these Terms of Service (“**Terms**”). If you do not agree, do not join or remain in the Community.

2. Eligibility

- **Age Requirement.** You must be at least **18 years old**.
- **Jurisdiction Limits.** You must not be barred from receiving services under U.S. or other applicable law.

3. Subscriptions, Billing & Pricing

1. **Plans & Prices.** Subscription tiers and current pricing are displayed on our live Whop storefront and may change without notice.
2. **Billing Cycle.** Each plan auto-renews for the period you select (e.g., monthly) unless you cancel before the next renewal.
3. **Platform of Record.** All payments, billing grace periods, failed-payment retries, and related notifications are governed by **Whop’s** platform terms, which may change from time to time.
4. **Price Changes.** We may modify fees or create new plans; changes apply at the next renewal after at least 7 days’ notice in the Community or by email.

4. No Refunds

Because access to proprietary content is delivered immediately, **all sales are final and non-refundable**.

5. Community Rules

The following conduct is prohibited:

- **Graduated Response.** Minor issues may receive a warning; serious or repeat violations may result in an **immediate ban** without refund, at our sole discretion.

- **Member Posts.** You own what you post but grant BBA a perpetual, non-exclusive, worldwide license to display that content inside the Community.
- **No Redistribution.** Screen-recording, copying, or sharing BBA content for commercial or financial gain is **strictly prohibited**.

8. Termination

We may suspend or terminate access, with or without notice, for:

- No refund is due upon termination.

9. Dispute Resolution & Governing Law

1. **Primary Venue.** Billing-related disputes must first be filed through Whop's platform.

2. **Escalation.** If unresolved, disputes shall be brought exclusively in the **state or federal courts located in Wyoming, USA** and governed by **Wyoming law**, without regard to conflict-of-law rules.
3. **Attorneys' Fees.** The prevailing party may recover reasonable legal fees and costs.

We may update these Terms at any time. Material changes will be announced in the Community or via email at least 7 days before they take effect. Continued use after the effective date constitutes acceptance.
