This Privacy Policy explains how MajorWager LLC (“MajorWager,” “we,” “us,” or “our”) collects, uses, shares, and protects information in connection with your use of our websites: <https://majorwager.app> and <https://app.majorwager.app> (collectively, the “Sites”), and any related services.

1. Information We Collect

We collect the following types of information:

MajorWager does not collect or store any payment information (e.g., credit card numbers or billing details). Whop is solely responsible for collecting and securing your payment data. We may receive limited information from Whop, such as your email address and subscription status, strictly for account management and support.
