Protecting your private information is our priority. This Statement of Privacy applies to **InvestiTrade** and governs data collection and usage. Collection of Your Personal Information

In order to better provide you with products and services offered, **InvestiTrade** may collect personally identifiable information, such as your:

- First and Last Name

If you purchase InvestiTrade's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us
- Comply with an existing legal obligation
