Because our programs and services involve **immediate delivery of proprietary content, business frameworks, e-commerce infrastructure setup, coaching access, and confidential mentorship systems**, the Company maintains a strict **No Refund Policy**.

By enrolling in or purchasing any Halal Hustle program, package, or service, you acknowledge and agree that **all payments are final, binding, and non-reversible**, and you **waive any right to initiate refunds, chargebacks, or reversals** through banks, processors, or courts. The only exception to this rule is the limited performance extension guarantee described below.

1. No Refunds

All purchases made through HalalHustle.io, Whop.com, or affiliated channels are **non-refundable under all circumstances**. This includes, but is not limited to:

- Branded dropshipping store setups and e-commerce infrastructure services
- Mentorship or coaching sessions (1-on-1, group, live, or recorded)
- Digital course modules and structured learning content
- Training webinars, workshops, or masterclasses
- Community memberships, private Discord/Telegram groups, or communication channels
- Downloadable templates, ads creatives, or proprietary frameworks
- Platform subscriptions, premium support, or bundled service packages

By completing a purchase, you agree and acknowledge that:

- You reviewed the program details, deliverables, and scope of services before enrolling.
 - Your decision to purchase is final and cannot be reversed once payment is made.
 - **Failure to attend live calls, use mentorship services, launch campaigns, or achieve specific financial/business outcomes does not qualify as grounds for a refund.**
 - **Personal reasons** such as lack of time, dissatisfaction, change in circumstances, or subjective views of “value” do not entitle you to any refund.
 - **Any attempt to file a chargeback or dispute** with a payment provider will be treated as a material breach of this Policy and may result in:
 - Immediate termination of access to all Halal Hustle platforms and services
 - Legal action or debt collection procedures for the disputed amount
 - Reporting of fraudulent disputes to relevant authorities and agencies

2. Exceptions & Guarantees

The Company does **not** provide monetary refunds under any package or program. However, we offer a **Performance Extension Guarantee** specifically tied to the **\$10K Success Package**:

- If you have enrolled in the \$10K package, completed **100% of the program requirements**, and have **not reached at least 100 verified customer orders** in your store, the Company will extend your access to mentorship, training, community, and digital resources **at no additional cost until you achieve this milestone.**

This guarantee represents an **extension of services only** and shall never be interpreted as the right to request a financial refund.

Eligibility is strictly conditional on the following:

- Completion of all required modules, calls, and mentorship steps
- Proof of good faith effort in implementing program strategies (e.g., ad launches, product testing, order fulfillment, campaign tracking)
- Ongoing compliance with Halal Hustle’s Terms of Service and policies

- Active participation and engagement within the mentorship and community platforms

Final determination of eligibility rests solely with the Company, whose decision will be binding. Failure to meet program requirements or demonstrate genuine implementation will result in forfeiture of this guarantee.

3. Dispute Resolution

All disputes, refund-related challenges, or disagreements regarding this Return Policy shall be handled **exclusively through Whop.com's internal dispute resolution system**, which governs all transactions conducted through the Whop platform.

By enrolling in any Halal Hustle service or product, you agree to:

- Submit fully to Whop's dispute system for resolution.
- Provide requested documentation or proof of eligibility if required.
- Accept Whop's final determination as binding and enforceable.

You expressly waive any right to pursue external chargebacks, disputes, or claims outside of this process.
