## 1. Information We Collect

In the course of delivering educational, mentorship, and community services, Halal Hustle may collect, process, and store certain categories of personal and technical information. Such data may include, without limitation, your identity data, which consists of your full name, your age, and your country of residence; your contact data, which may consist of your email address, telephone number, Telegram or WhatsApp handles, and similar information that enables communication; your account data, including but not limited to login credentials, membership identifiers, user-generated content, and program completion progress; your payment data, which may include billing addresses, purchase history, subscription details, and transaction logs as recorded through third-party processors such as Stripe, PayPal, or other authorized gateways, noting that the Company itself does not directly store your complete payment card details; and your technical data, which may consist of IP addresses, browser versions, device specifications, geolocation metadata, session usage logs, and related analytics information automatically collected during your interaction with our systems.

## 2. How We Use Your Data

The Company uses personal data in a lawful and transparent manner for specific purposes connected to the provision of its services. These purposes include the management and facilitation of your enrollment into programs, the granting of access to course content, mentorship sessions, and community platforms, the maintenance of accurate user account

details, the administration of program progress, and the delivery of support or transactional communications required to fulfill our obligations to you. Data may also be used for fraud prevention, detection of suspicious activities, enforcement of compliance, and security measures necessary to protect both the integrity of the platform and the safety of its users. In addition, data may be processed in order to enhance the user experience, improve course content, and refine program offerings in line with user performance and feedback. Where required under UAE law, data will also be used to ensure compliance with financial, commercial, and regulatory obligations. The Company does not, under any circumstances, sell or rent user data to third parties.

### **3. Data Sharing**

We may share your data strictly on a limited basis with trusted third-party service providers who are contractually bound to confidentiality and who are necessary to the operation of the services, including hosting providers, payment processors, cloud storage platforms, and email automation systems. Data may also be disclosed to competent legal or regulatory authorities where required under UAE law or under valid legal process. Furthermore, within the Company, data may be shared only with employees, contractors, or agents operating under strict confidentiality obligations and only to the extent necessary to perform their designated roles in providing you with services.

### **4. Data Storage and Security**

Halal Hustle employs commercially reasonable, industry-standard practices to store and secure user data, including encryption protocols, firewalls, restricted access controls, and regular monitoring of systems. While every effort is made to protect data, users acknowledge that no online transmission or storage system can be guaranteed to be 100% secure. By engaging with the services, you accept the inherent risks associated with internet-based transactions and communications and agree that the Company shall not be held liable for breaches arising from factors outside of its reasonable control.
