- **Subscriptions:** Auto-renew monthly until canceled.
- **Content:** Don't share, resell, or republish our content. It's our intellectual property.

1. ACCEPTANCE OF TERMS

Welcome to OddsCap ("Company," "we," "us," or "our"). By accessing or using our sports intelligence platform and services (the "Service"), you agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, do not use our Service.
