## 2. INFORMATION WE COLLECT

### 2.1 Information You Provide

**Account Information:** Name, email address, username

**Payment Information:** Processed securely through Whop (we do not store credit card details)

**Communication Preferences:** Email delivery settings and preferences

**Support Communications:** Information provided when you contact us

### 2.2 Information Collected Automatically

**Usage Data:** Pages visited, features accessed, time spent on site

**Device Information:** Browser type, operating system, IP address

**Cookies:** Session cookies and analytics cookies for site optimization

**Pixels:** Analytics pixels and tracking technologies

### 2.3 Information We Do NOT Collect

Betting history or gambling activity

Financial account information

Location-based tracking data

Sensitive personal information

## **3. HOW WE USE YOUR INFORMATION**

We use collected information to:

- Provide and improve our Service
- Process subscriptions and payments
- Send analytical content and predictions
- Communicate service updates
- Respond to support requests
- Analyze usage patterns for optimization
- Ensure security and prevent fraud
- Comply with legal obligations

## **4. INFORMATION SHARING**

### **4.1 We Do Not Sell Your Data**

We never sell, rent, or trade your personal information to third parties.

### **4.2 Limited Sharing**

We may share your information only:

- With Whop for payment processing
- With service providers who assist our operations (under strict confidentiality)
- To comply with legal obligations
- To protect our rights and prevent fraud
- With your explicit consent

We implement industry-standard security measures including:

- Encryption of sensitive data
- Secure server infrastructure
- Limited access controls
- Regular security audits
- Secure payment processing through Whop
