KAZUMI'S SQUIRTS LLC TERMS OF SERVICE

INTRODUCTION

Kazumi Squirts LLC, provides its services, which include but are not limited to online education-based services, Personal Coaching. The Services are provided to you subject to the following Terms of Service (the "Terms of Service"). PLEASE READ THESE TERMS OF SERVICE CAREFULLY, AS THEY GOVERN YOUR USE OF THE SITE AND SERVICES, WHICH AFFECTS YOUR RIGHTS IN THE EVENT OF A DISPUTE BETWEEN US.

1. Access to the Services.
