

End User License Agreement (EULA)

This End User License Agreement (“**Agreement**”) is a legal agreement between you (“**User**,” “**you**,” or “**your**”) and **Luxury Team** (“**Luxury Team**,” “**we**,” “**us**,” or “**our**”) governing your access to and use of our proprietary software platform, website, and related services (collectively, the “**Software**” or “**Platform**”).

3. Restrictions on Use

You agree **NOT** to:

- Reverse-engineer, decompile, disassemble, or attempt to derive the source code.
- Circumvent, disable, or tamper with any security or authentication mechanisms.
- Use the Platform in any manner that violates applicable law or this Agreement.
- Use the Platform to develop or support competing services or software.

Violation of any of the above will result in **immediate termination** of your license without notice or refund and may lead to legal action.

4. Subscription and Access

- Access to the Platform is provided as part of a subscription plan.
 - Once access is granted, the service is considered delivered.
 - Failure to use the Platform does not entitle you to a refund.
 - Luxury Team reserves the right to modify, suspend, or discontinue any part of the Platform at its discretion.

We may also revise this Agreement as necessary. Continued use of the Platform after such changes constitutes your acceptance of the revised Agreement.

10. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the **State of Nevada, United States**, without regard to its conflict of law principles.

Any disputes arising out of or relating to this Agreement shall be resolved exclusively in the state or federal courts located in **Las Vegas, Nevada**, and you consent to the jurisdiction of those courts.

11. Entire Agreement

This Agreement constitutes the entire agreement between you and Luxury Team regarding the use of the Platform and supersedes all prior agreements, understandings, or representations related to its subject matter.
