

Terms of Service

Welcome to Luxury Team (“Luxury Team,” “we,” “us,” or “our”). These Terms of Service (“Terms”) govern your access to and use of our platform, website, and any associated products, features, or digital services (collectively, the “Services”). All disputes shall be resolved exclusively in the state or federal courts located in Las Vegas, Nevada, and you consent to the personal jurisdiction of those courts.
