This Privacy Policy explains how **Data Trader Media FZ LLC** ("we", "us", or "our") collects, uses, stores, and protects your personal data when you visit our website, register for services, or interact with any content or features we provide.

1. Information We Collect

We collect two types of information:

a) Personal Information

This refers to any information that can be used to identify you directly or indirectly, including:

- Full name
- Email address
- Phone number
- Payment or billing information (if applicable)
- Any other information you voluntarily provide through registration forms, subscriptions, or correspondence.

b) Non-Personal Information

This refers to aggregated or anonymized data that does not identify you individually, such as:

- Browser type and version
- Device type
- IP address
- Time zone and location data
- Usage statistics and navigation patterns

2. How We Use Your Information

We use your information to:

- Process account registrations and service requests

- Improve site functionality and user experience
- Comply with legal obligations or enforce our Terms of Service

3. Legal Basis for Processing (Fujairah Creative City – Media Free Zone)

- Legal authorities, if required to comply with a legal obligation or enforce our rights

We retain your personal information only as long as necessary to fulfill the purposes described in this policy or to comply with legal and regulatory obligations.

6. Your Rights

Subject to applicable law, you have the right to:

- Access and obtain a copy of your personal data

- Request deletion of your data (subject to legal retention obligations)
- Object to or restrict certain data processing activities
- Withdraw your consent where processing is based on consent
