

Faceless Paydays — Terms of Service

Effective Date: The date of your online purchase (transaction date shown in your Whop receipt).

Platform: Access provisioned via Whop (and related delivery methods)

These Terms of Service ("Terms") govern your access to and use of the programs, courses, digital products, memberships, communities, and related services (collectively, the "Services") provided by Faceless Paydays ("Faceless Paydays," "we," "us," or "our") and made available via Whop or other platforms we use to deliver and manage access ("Whop"). By purchasing, accessing, or using the Services via Whop, you agree to be bound by these Terms as well as Whop's applicable terms, policies, and rules. If you do not agree, do not access or use the Services.

Note: Your purchase, subscription, and access logistics (including billing and cancellation mechanics) may be managed by Whop. Where there is a conflict between these Terms and Whop's platform rules for transactional logistics, Whop's applicable terms may control only for those logistics; all other issues are governed by these Terms.

1. Eligibility and Accounts

- You must be at least 18 years old and have legal capacity to enter into a binding contract.
- You are responsible for your account, including maintaining the confidentiality of login credentials and restricting access to your devices. You are responsible for all activities that occur under your account.

2. Access via Whop

- Access to the Services may be provisioned, gated, or authenticated through your Whop account. You must comply with Whop's terms, including payment, renewal, cancellation, and acceptable use policies published by Whop.
- We may update how we deliver or verify access, including changing communities, course portals, or delivery methods, without prior notice, provided your material access rights under your active purchase are preserved.

3. Pricing, Payments, and Taxes

- Prices and payment terms are disclosed at checkout on Whop. Taxes and fees may apply. You authorize Whop (or its payment processors) to charge your selected payment method per the terms at purchase.
- If a payment fails or is reversed, we may suspend or terminate your access until the amount is paid. You are responsible for any chargeback fees, collection costs, and reasonable attorneys' fees arising from nonpayment or reversed transactions inconsistent with these Terms.

4. Refunds and Cancellations

- Unless expressly stated at the point of sale on Whop, all sales are final and nonrefundable.
- Subscription products may be cancelled per Whop's platform instructions. Cancelling a subscription prevents future renewals but does not entitle you to a refund of amounts already paid, unless expressly stated at purchase.
- Any attempt to circumvent these terms through chargeback or reversal inconsistent with these Terms and the applicable Whop terms is ineffective, invalid, and unenforceable. You agree to be responsible for reasonable costs (including attorneys' fees) incurred in responding to such actions.

4. The termination and cancellation methods described in these Terms and through Whop constitute the sole means of terminating your access. Any effort to cancel, chargeback, reverse, or recoup any payment inconsistent with these Terms or Whop's rules is ineffective, invalid, and unenforceable. If you initiate such efforts, you will be responsible for our costs of responding (including reasonable attorneys' fees), regardless of outcome.
5. Sections that by their nature should survive termination (including payment obligations, intellectual property, disclaimers, limitations of liability, prohibited practices, indemnification, governing law, arbitration, and dispute time limits) will survive.

E. Intellectual Property Rights

1. **User Materials.** You represent and warrant that you own or have appropriate licenses and permissions to any content, data, trademarks, or other materials you provide or upload ("User Materials"). You agree to indemnify and hold Faceless Paydays harmless from any losses, claims, damages, or expenses (including reasonable attorneys' fees) arising from allegations that User Materials infringe or misappropriate any intellectual property or other rights.
2. **Our Materials.** Faceless Paydays owns all right, title, and interest in and to the Services and all related content and materials, including courses, curricula, videos, templates, workbooks, slide decks, worksheets, lesson plans, community content we

create, designs, trade secrets, know-how, documentation, and all associated intellectual property and proprietary rights, whether provided via Whop or otherwise ("Faceless Materials").

- *License Grant:* Subject to your compliance with these Terms and timely payment of all fees, Faceless Paydays grants you a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to access and use the Faceless Materials solely for your personal, non-commercial use during the access period associated with your purchase.
- *Restrictions:* You may not copy, reproduce, modify, adapt, translate, republish, mirror, resell, rent, lease, loan, assign, sublicense, distribute, transmit, scrape, or publicly display or perform the Faceless Materials, in whole or in part, except as expressly permitted in these Terms. F. Acknowledgment About Your Business

1. You acknowledge that you are solely responsible for your business decisions, including your brand, products or services, operations, compliance, and relationships with vendors or platforms. Faceless Paydays does not offer a "business opportunity," "franchise," or "employment." We may provide educational information and case studies, but you remain solely responsible for all outcomes, actions, compliance, and risk management.
2. Any third-party vendors, platforms, payment processors, printers/fulfillment, ad networks, or tools referenced in the Services are independent third parties. We do not control or endorse them and are not responsible for their performance, practices, or compliance.

H. Prohibited Practices

J. Non-Assignment

You may not assign, transfer, or delegate these Terms or any rights or obligations hereunder without our prior written consent. Any attempted assignment in violation of this section is null and void. We may assign these Terms in connection with a merger, acquisition, corporate reorganization, or sale of assets.

K. Time Limits to Raise Disputes

NOTWITHSTANDING ANY "DISCOVERY RULE," STATUTE OF LIMITATIONS, OR OTHER LAW, YOU AGREE TO NOTIFY FACELESS PAYDAYS IN WRITING OF ANY CLAIM OR DISPUTE ARISING OUT OF OR RELATING TO THESE TERMS OR THE SERVICES WITHIN SIX (6) MONTHS OF THE EARLIEST OF: (A) THE PURCHASE DATE; OR (B) THE DATE THE FACTS GIVING RISE TO THE CLAIM FIRST OCCURRED OR SHOULD HAVE BEEN DISCOVERED WITH REASONABLE DILIGENCE. IF YOU DO NOT PROVIDE SUCH NOTICE WITHIN THIS PERIOD, YOU IRREVOCABLY WAIVE THE CLAIM.

L. Arbitration; Class Waiver; Governing Law; Venue

- 1. Binding Arbitration:** Any dispute, claim, or controversy arising out of or relating to these Terms or the Services will be resolved exclusively by binding arbitration administered by the American Arbitration Association (AAA) under its Commercial Arbitration Rules. The seat and venue of arbitration will be Bexar County, Texas, and the language will be English. The arbitrator may award any relief available in court, including injunctive relief, subject to the limitations set forth in these Terms.
- 2. Arbitrator Selection:** The arbitrator will be appointed by the AAA following its rules. If the parties mutually agree, JAMS may be used as an alternative forum, applying the

JAMS Comprehensive Arbitration Rules, with the arbitration also seated in Bexar County, Texas.

3. **Class and Representative Action Waiver:** YOU AND FACELESS PAYDAYS AGREE THAT EACH MAY BRING CLAIMS AGAINST THE OTHER ONLY IN YOUR OR ITS INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS, COLLECTIVE, OR REPRESENTATIVE PROCEEDING.
4. **Governing Law and Venue:** These Terms are governed by the laws of the State of Texas, without regard to its conflict of laws principles. To the extent any claim is permitted to proceed in court (e.g., to enforce arbitration awards or seek injunctive relief), the exclusive jurisdiction and venue will be the state and federal courts located in Bexar County, Texas, and you consent to personal jurisdiction there.
5. **Prevailing Party:** In any arbitration or permitted court proceeding, the prevailing party is entitled to reasonable attorneys' fees and costs in addition to any other relief.

M. Limitations of Liability

- **Indirect Damages:** To the fullest extent permitted by law, Faceless Paydays will not be liable for any indirect, incidental, special, consequential, exemplary, or punitive damages, including lost profits, lost revenue, loss of data, business interruption, or procurement of substitute goods or services, arising out of or related to these Terms or the Services, even if advised of the possibility of such damages.
- **Aggregate Cap:** Our total aggregate liability for all claims arising out of or related to these Terms or the Services will not exceed the amounts you paid for the specific Service giving rise to the claim during the three (3) months immediately preceding the event giving rise to liability.
- These limitations apply to the maximum extent permitted by law and form an essential basis of the bargain.

N. Changes to the Services or Terms

We may modify the Services or these Terms from time to time. Material changes will be effective upon posting to our listing or notice via Whop or email. Your continued access or use after the effective date constitutes acceptance of the updated Terms. If you do not agree, you must stop using the Services and, if applicable, cancel your subscription per Whop's instructions.

O. Privacy

Your use of the Services is subject to our Privacy Policy and Whop's privacy policies. We may process personal data to provide and improve the Services, comply with law, and protect our rights. Refer to the privacy information presented at purchase or on our profile/listing.

P. Third-Party Platforms and Tools

The Services may reference, integrate, or link to third-party tools, platforms, or content, including Whop. We are not responsible for third-party services or content, and you use them at your own risk subject to their terms and policies.
