AI Mafia (“Company”, “we”, “our”, or “us”) respects your privacy and is committed to protecting your personal information.

This Privacy Policy explains how we collect, use, and protect your information when you access our website, Whop store, Telegram channels, or any of our online programs and services (collectively, the “Services”).

1. INFORMATION WE COLLECT

We collect information from you in the following ways:

a. Information You Provide Directly

When you register, purchase, or interact with AI Mafia, you may provide:

- Full name
- Email address
- Phone number / Telegram handle
- Billing and payment information (processed securely via Whop or third-party providers)
- Social media usernames (if connecting accounts)
- Responses to surveys, applications, or intake forms

b. Information Collected Automatically

When using our websites or portals, we may automatically collect:

- IP address, browser type, and device identifiers
- Usage patterns and activity logs
- Referring URLs, timestamps, and analytics data
- Cookies and similar technologies for session tracking

We do **not** collect sensitive personal data (race, religion, political affiliation, health information, etc.).

2. HOW WE USE YOUR INFORMATION

We use your data for the following lawful purposes:

1. To provide, maintain, and improve our Services

2. To process your orders and deliver purchased programs
3. To send account information, confirmations, and updates
4. To provide mentorship, support, and community access
5. To improve user experience through analytics and feedback
6. To send marketing communications (only with consent)
7. To comply with legal and financial obligations

We may occasionally personalize offers or educational materials based on your interests or progress within the program.

3. DATA STORAGE AND SECURITY

Your information is securely stored on encrypted servers and protected by industry-standard security protocols (SSL/TLS encryption, firewalls, password protection, and restricted access).

Payment details are **never stored on our servers** – all transactions are securely processed via Whop and trusted PCI-DSS compliant gateways (Stripe, PayPal, etc.).

While no system is 100% secure, AI Mafia implements continuous monitoring and security audits to minimize risks of data loss or unauthorized access.

4. DATA SHARING AND THIRD PARTIES

We do **not** sell, rent, or trade your data to third parties.

We may share limited information with:

- **Service Providers** (payment processors, analytics tools, email platforms)
- **Whop** (for hosting and account management)
- **Law enforcement** (if required by law or to protect our rights)

All third-party partners are required by contract to maintain strict data confidentiality and security.

5. YOUR RIGHTS AND CHOICES

You can disable cookies in your browser settings, though some features may not function properly.
