## 2. Restrictions

- Circumvent access controls or share your login credentials with others.

Any violation of these restrictions will result in **immediate termination** of your license and may result in legal action.

## 3. Ownership

  - You may cancel at any time before the next renewal date.
  - No refunds are provided for subscription renewals or partial billing periods.
