1. Information We Collect

We may collect the following types of information:

2. How We Use Your Information

We use collected data for purposes including:

3. Legal Basis for Processing (if applicable)

Contractual necessity — to deliver our services to you

Legitimate interests — to improve our service and website (so long as balanced with your rights)

Legal obligations — when required by law

4. Data Sharing and Disclosure

We may share your information with:

Third-party service providers who help us operate the website (e.g., hosting, analytics)

Marketing partners (if you have consented)

Legal or regulatory authorities if required by law or to protect our rights

We do not sell your personal data.

5. Data Retention

We will retain your personal data only as long as necessary to fulfill the purposes for which it was collected, or to comply with legal obligations. After that, we will securely delete or anonymize it.

6. Your Rights

Depending on your location, you may have the following rights regarding your personal data:

Right to access your data

Right to correct or update your data

Right to delete your data (“right to be forgotten”)

Right to object to certain processing

Right to withdraw consent (if that’s our basis for processing)

Right to data portability (in some cases)
