5. ACCOUNT MONITORING & FRAUD PREVENTION

We reserve the right to monitor accounts for:

- Unauthorized sharing of login credentials
- Duplicate logins from suspicious locations
- Policy violations
- Fraud, chargeback attempts, or abusive behavior

Violations may lead to IMMEDIATE account termination without refund.

6. SHARING OF INFORMATION

We may share information only with:

- Payment processors (for billing verification)
- Legal authorities (if required by law)
- Platforms such as Whop for fraud prevention and account enforcement

We do NOT share your information for marketing by third parties.

7. USER RIGHTS

You may request:
