PUBLIC COMMENT

Chairperson Ward Gerson opened the meeting to public comment. There was no public comment.

EXECUTIVE DIRECTOR'S REPORT

Carrie Lewand-Monroe, Acting Executive Director, provided an overview of the DLBA's prior month, beginning by reporting 824 auction sales and 2,691 side lot sales since inception, noting the Disposition department recent restructuring, allowing for increased sales. Mrs. Lewand-Monroe introduced the 4 Disposition Managers, noting each of their roles in the department. Mrs. Lewand-Monroe also noted that the DLBA continues its search for a Disposition Director. Mrs. Lewand-Monroe discussed Nuisance Abatement Program and reported its 3,336 lawsuits filed to date, along with 861 Compliance Agreements, which compel owners to update their homes.

Pura Bascos, Director, Acquisitions and Land Reuse (AL&R), provided an update on the partnership with the Michigan State Housing Development Authority (MSHDA) and discussed an upcoming training for team that will assist with most efficiently reporting demolition data to MSHDA.
