#### **CALL TO ORDER**

Chairperson Ward-Gerson called the June 7, 2016 meeting to order at 12:17 P.M.

## **ROLL CALL**

All Board members were present and a quorum was met.

## ADOPTION OF THE AGENDA

Chairperson Ward Gerson requested comments from the Members of the Board for the Agenda as distributed. Noting none, the Agenda was adopted.

## **PUBLIC COMMENT**

Chairperson Ward Gerson opened the floor to public comment, noting none was offered.

## **OLD BUSINESS**

## **Closed Session Roll Call Votes.**

## **Compliance Audit – Candidate Interviews.**

Chairperson Ward Gerson welcomed Experis Manpower Group and explained the process and expectation from the firm. Paula Patterson, Director of Experis Manpower Group, introduced herself and her team and provided a presentation to the Board. A discussion ensued. Chairperson Ward Gerson dismissed Experis Manpower Group and confirmed the firm would be contacted once a decision was

made. Members of the Board discussed and completed scoring. Chairperson Ward Gerson welcomed Plante Moran and explained the process and expectation from the firm. Michelle McHale from Plante Moran introduced herself and provided a presentation to the Board. A discussion ensued. Chairperson Ward Gerson dismissed Plante Moran and confirmed the firm would be contacted once a decision was made. Members of the Board discussed and completed scoring.

Members of the Board then discussed next steps once a firm was contracted. Members agreed assignments would be determined via the Committees and then confirmed by the Board.

## Resolutions.

Resolution 05-04-2016, Resolution Authorizing the Executive Director to enter into a Services Agreement on behalf of the Detroit Land Bank Authority with the Program Compliance and Audit Firm selected through the Request for Proposals Process. Chairperson Ward Gerson and Michelle Story-Stewart, Chief Financial Officer, led a discussion based on the candidate interviews. As a result of the discussion, Chairperson Ward Gerson requested two amendments to the resolution: to note Experis Manpower Group as the firm selected through the Request for Proposals Process; to indicate authorization to enter into Agreement is pending a reference check.
