#### **General Notes and Guidelines for Fired Rated Doors**

Under **NO CIRCUMSTANCE** will we (Dyke Industries) ever send a fire label to a customer because the customer failed to order, or they removed a fire label. The fire labels must be applied in our shop and no where else.

A fire rated door *system* (a system is the frame, door, closing mechanism, locking mechanism, and weather stripping combined) assumes the rating of the lowest rated component in the system. (i.e.-a system with a 20-minute door and a 90-minute frame only has a 20-minute system rating, a system with a 20-minute door and a non-rated frame is a non-rated system.)

Codes and code interpretations vary in every region we serve. We will supply whatever the customer asks for; however, our customer (or his customer) should be certain what the fire inspector in that area will and will not allow.

All fire rated door *systems* should have a self-closing mechanism of some form. This can be achieved with a door closer or spring-loaded hinges. If neither of these is used, the *system* would loose the fire rating even though the label is on the door and/or frame.

Unmachined doors will not be sold with fire labels.

All fire rated doors should have a "panic-proof" lock mechanism which only takes one action to open and no more than 90 degrees of turn to open.

While some inspectors allow deadbolts in some areas, other inspectors turn down a door with a deadbolt in many areas.

Warnock-Hersey does allow deadbolts. Once again, the customer should be aware of what is allowed in their particular area.

The maximum amount of glass in a 90-minute fire rated door is 100 square inches. This can be achieved by using a 10"X10" or 3"X33" insert. All glass must be wire glass, ceramic glass, or a form of Lexan to be used in a fire rated door.

The maximum amount of glass in a 20-minute fire rated door is 1296 square inches. All glass must be wire glass, ceramic glass, or a form of Lexan to be used in a fire rated door.

We will never assume the responsibility for what an inspector will or will not pass during his inspection. That responsibility falls with the end user to determine what they need to pass inspection; however, we will <u>never</u> do anything that breaks the rules of what we are allowed to do to a fire rated door as that would jeopardize our certification.


#### **Knockdown Light Commercial Frames**


