DISCLOSURE STATEMENT

Effective Date: December 31, 2022

The Elite Alliance, LLC ("Elite Alliance") is a Texas Limited Liability Company established to facilitate the exchange of accommodations between members of prestigious residence clubs and luxury, professionally managed homes ("Residence Clubs") that meet the standards of Elite Alliance. This Disclosure Statement is provided to explain the Elite Alliance exchange program ("Exchange Program") which is offered to the members of and owners in participating Residence Clubs ("Owners"). Capitalized terms not otherwise defined herein, shall have the meanings set forth in that certain Elite Alliance Membership Agreement ("Membership Agreement").

The Company

The Elite Alliance, L.L.C., a Texas limited liability company, whose principles are; Stephen Dering and Rob Goodyear, and is located at 100 Corporate Woods, Suite 220, Rochester, NY 14623. Except as stated in this paragraph, neither Elite Alliance nor any of its officers or directors has any legal or beneficial interest in any developer, seller, or managing entity for any Residence Club participating in the Exchange Program.

The Exchange Program

The Membership Agreement is a contract separate and distinct from the Owner's contract to purchase an interest in a participating Residence Club. Owners participate directly in the Exchange Program with Elite Alliance and such participation is completely voluntary. In order to become a Member of the Exchange Program, Owners must enter into a Membership Agreement with Elite Alliance, which sets forth the terms and conditions of a member's participation in Elite Alliance. Elite Alliance may, from time to time in its sole and exclusive discretion, modify the terms and conditions set forth in the Membership Agreement, including, but not limited to, all applicable exchange fees. Members will be provided written notice of any such modifications.

A member's participation in the Exchange Program is dependent upon the continued affiliation of Elite Alliance with such member's Home Residence Club. Exchange privileges are conditioned upon the Home Residence Club's adherence to high standards of service, appearance, management, operation and compliance with the obligations set forth in the Participation Agreement with Elite Alliance. In the event that the Participation Agreement is terminated, the members in the unaffiliated residence club will no longer be able to participate in the Exchange Program. However, all existing Accepted Vacations will be honored.

In order to make an exchange, a member must first secure a Vacation at his or her Home Residence Club and submit a Deposited Vacation Form to Elite Alliance. The Vacation must be deposited at least ninety (90) days prior to the arrival date of the Vacation, to earn Elite Credits immediately. If deposited less than ninety (90) days prior to the arrival date of the Vacation, the depositing member will earn Elite Credits when the Deposited Vacation is selected for exchange by another member in the exchange. Once a Vacation is deposited into the Exchange Program, the member relinquishes all rights to use, cancel or change the Vacation and assigns all rights to use the Vacation to the Exchange Program, unless the Deposited Vacation is still available, the member has not accepted a Vacation and the Deposited Vacation is withdrawn more than twenty-one (21) days prior to the Deposited Vacation arrival date.

Elite Credits vary from Residence Club to Residence Club, are determined based on seasonality, destination and bedroom category and are allocated by Elite Alliance. A member may accept a Vacation by submitting an Accepted Vacation Form to the Elite Alliance along with the Exchange Fee, so long as the member has the proper amount of Elite Credits within their Member Account. An Accepted Vacation shall be confirmed upon the Elite Alliance's approval of the Accepted Vacation Form, in writing, and receipt of the Exchange Fee. A member's Elite Credits expire twenty-four (24) months from the arrival date of the Vacation that the member deposits, if the deposit is made at least ninety (90) days from the arrival date of the deposited vacation, or if deposited less than ninety (90) days from the arrival date of the deposited vacation, when the Deposited Vacation is selected by another member for exchange. The Elite Credits allocated to a member for a Deposited Vacation may be used in part or in whole. If a member does not submit an Accepted Vacation Form within such twenty-four (24) month period, the Member will no longer be able to redeem their Elite Credits unless they elect to extend their Elite Credits for 6 months for \$195.00. When accepting a Vacation, should a member have insufficient Elite Credits in their account, the member may purchase additional Elite Credits for \$75.00 per Elite Credit. Should a Deposited Vacation go unused in the exchange, it is offered to members as an Elite Escape. Elite Escapes may be purchased by members for \$695.00 - \$1,995.00, no more than forty-five (45) days before the Deposited Vacation's arrival date, without the use of Elite Credits by the member purchasing the Elite Escape. A member may cancel an Accepted Vacation by providing written notice to Elite Alliance. If a member cancels an Accepted Vacation ninety (90) days or more prior to the arrival date of that Vacation, the member may accept a new Vacation. However, the Exchange Fee will be forfeited, and an additional Exchange Fee will be due for any new Accepted Vacation. In the event a member cancels an Accepted Vacation less than ninety (90) days prior to the arrival date of that Vacation, the right to accept another Vacation and the Exchange Fee will be forfeited.

Vacations are available on a first-come, first-served, space available basis and Elite Alliance does not guarantee the fulfillment of any specific request.

Membership Fees

As of December 31, 2022, qualified Owners are required to pay annual membership fees of \$495.00 - \$795.00. The Exchange Fee is due upon submittal of an Accepted Vacation Form. The Exchange Fee is nonrefundable and currently ranges from \$395.00 (U.S. Dollars) to \$895.00 (US Dollars), depending on the location and period of time exchanged. The Exchange Fee includes all applicable local, state and federal taxes. Exchange Fees must be paid before an Accepted Vacation will be confirmed. Exchange Fees may be increased from time to time by the Elite Alliance, in its sole discretion, upon notice to the Members.

Residence Clubs

The names and addresses of all currently participating Residence Clubs are set forth on Exhibit A attached to this Disclosure Statement. Additions to or deletions from the participating Residence Clubs list are at the sole discretion of Elite Alliance.

Exchange Statistics

There are currently 7,696 Members enrolled in the Exchange Program and the number of members enrolled at each participating Residence Club is set forth on Exhibit A attached to this Disclosure Statement. The number of participating Residence Clubs as of the date of this Disclosure Statement is 83. The number of properly applied for exchanges confirmed during 2022 was 1,468. The total percentage of properly applied for exchanges fulfilled in 2022 was 100%. The number of exchanges for which Elite Alliance has an obligation as to the Exchange Program as of yearend to provide in a subsequent period to a member provided such Member properly applies for an exchange is 4,770. At December 31, 2022, Members had accumulated 200,366 Elite Credits for which they have the right to a reservation opportunity in 2023 or 2024. This represents a total of approximately 4,770 deposited Vacations based on an average number of Elite Credits per deposit of 42. **The exchange percentage is a summary of the exchange requests entered with Elite Alliance during the year of 2022. Such percentage does not indicate the probabilities of a member being confirmed to any specific choice, as availability at individual locations may vary.**

The exchange statistics were calculated using properly submitted Accepted Vacation Forms (as defined in the Membership Agreement) in accordance with the Membership Agreement and other instructions given to Members by Elite Alliance. Currently enrolled members of Elite Alliance consist of all purchasers who have submitted a Membership Agreement to Elite Alliance. In order to properly apply for an exchange, Members must complete all forms and pay all applicable fees as provided in the Membership Agreement.
