Required:

Course Description:

Operations & Business Analytics 3230 is designed to provide students with a broad understanding of how effective operations and supply chain management practices contribute to the competitiveness and survival of manufacturing, service, and non-profit organizations. Students will apply selected concepts, tools, and methods to address strategic and tactical operational challenges with a systems perspective.

Course Learning Outcomes:

By the end of this course, students should successfully be able to:

- Explain how operations and supply chain practices contribute to the overall competitiveness of any organization and its value chains.
- Recognize and evaluate operational challenges and opportunities from a holistic perspective.
- Apply various concepts, methods, and tools by structuring, analyzing, and solving complex operational problems.
- Generate questions and curiosity to encourage future learning in operations and supply chain management.

How This Course Works:

Mode of delivery: All lectures and recitations are in-person.

Pace of online activities: This course is divided into **weekly modules** that are released one week ahead of time. Students are expected to keep pace with weekly deadlines (Sunday Midnight) but may schedule their efforts freely within that time frame.

Credit hours and work expectations: This is a **3-credit-hour course**. According to <u>Ohio State policy</u>, students should expect around an average of 3 hours per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 6 hours of homework (reading and assignment preparation, for example).

Attendance and participation requirements: Your presence in class is mandatory. All in-class assignments are graded for accuracy. The following is a summary of everyone's expected participation:

• Preparation for Lecture:

You are expected to complete SmartBook (SB) assignment prior to Lecture. The SB provides the foundation for the student to participate in Lecture for the week's topics.

During the live lecture, the week's topic will be presented and discussed. In-class assignments will enable engagement and achievement of learning outcomes through active learning. All assignements are graded for accuracy and due by END of your registered lecture.

Recitation sessions:

Students will be working individually and in teams to complete assignments involving problems related to each weekly topic. Assignments are graded for accuracy and due by END of your registered recitation.


