Course description

The beginning of this program focused on students developing an understanding on the four components of the operational excellence systems and implementing management systems in their organization. This session is all about sustaining the systems, and transferring the learnings from their local "model cells" towards the larger organization. Students will spend time (sponsors invited to Friday sessions) understanding the principles that allows organizations to sustain their capabilities through people development and strategic transformations. We will also learn more on the power of reflection and learning from failures and how they can help organizations adapt to changing needs. Finally, we will hear from change agents from well-known healthcare organizations on how they were able to develop a learning

culture within their organizations.

Course learning outcomes

By the end of this week, students should successfully be able to:

- 1) Understand the importance of sustaining learning management systems
- 2) Learning from failures and power of reflection
- 3) Role of people development and service-profit chains
- 4) Measuring your organization's adaptability
- 5) Transferring learnings beyond Model Cell
