#### **Course Objective and Description**

AMIS 3200 is the first course in a two-semester intermediate accounting sequence. This course is a prerequisite to AMIS 3201. Taken as a whole, they represent the core financial accounting subject matter of the undergraduate accounting curriculum.

We have designed the requirements for 3200, recognizing that nearly all of the students intend to pursue a professional career with an emphasis on accounting. Although students will choose to pursue employment with a variety of firms, not just major international accounting firms, you nonetheless should be prepared to achieve the same basic knowledge and skills expected of all accounting professionals and are likely to seek certifications as a CPA. This course focuses on this knowledge and skill set, as does 3201.

The essential subject matter of the 3200 course is an in-depth study of financial statement content and use, mainly focusing on matters related to operating activities and long-term operational assets. Essential to this study is an understanding of the reporting environment in which the SEC and FASB regulate our capital markets and through which companies regularly provide audited financial information to capital providers and other stakeholders with vested economic interests.

Your learning of this material requires a highly disciplined routine, including reading and understanding key ideas, regular practice of accounting methods and techniques, and critical analysis of issues through which the knowledge is applied in practice. As students seeking to become professionals in this field, it is essential that you also begin to follow the intellectual development in the academic discipline of accounting. Much of today's leading thinking about accounting policies and practice originated in rigorous theorizing and empirical analysis.

In addition to conceptual and technical knowledge, 3200 and 3201 are designed to build and exercise the essential skills of a professional accountant, particularly communication skills and professional research and inquiry skills. Employers, as well as professional and graduate schools, all seek candidates who have developed these skills so that they can be employed at the next level.

## How to Succeed in this Class

The material covered in 3200 is significantly more complex than in prior accounting classes. This is *not* a class in which you can succeed by merely attending the lecture and studying just before an exam. Your chances of performing well on the quizzes and exams in my class will be greatly improved if you read the assigned textbook chapter before our class discussion on the material. Even if you don't completely understand all the material on your first pass through the textbook, you will get much more out of our class discussion if you have already been introduced to the material in the textbook. Also, I recommend actively jotting down notes and questions when reading the text, and regularly re-visiting those notes to assess where you need to allocate more of your study time.

Doing well on exams will require that you read the chapters thoroughly, participate actively in class discussions, take notes in class, and work the suggested practice problems. The university and college expectation is that students spend two hours outside of class for every hour spent in class. Since this course meets 3 hours per week, you should expect to spend 6 hours per week outside of class on course-related work.

#### **Academic Conduct**

Academic integrity is essential to maintaining an environment that fosters excellence in teaching, research, and other educational and scholarly activities. Letter grades will be assigned according to traditional grading scales (89 - 87 B+; 86 - 83 B; 82 - 80 B-; etc.). The average grade granted in prior sections of this course (i.e., 3200) has historically been a "B."

#### **Exams**

There is a 150-point midterm exam and a 200-point final exam. These tests will be administered online. More information TBD.

Missed exams can only be made-up in extreme cases (e.g., the death of family member, personal hospitalization, etc.) with proper documentation (e.g., a physician's note, ER paperwork, obituary, etc.). The instructor makes each decision of potentially allowing a make-up exam on a case-by-case basis. Additionally, you MUST contact me (Geoffroy.1@osu.edu) as soon as you know of a potential problem or conflict with an exam date. Alternative methods (e.g., oral exam, essay) of testing may be used for

make-up exams. If you are experiencing an extreme situation or emergency, please attempt to notify me by email ASAP.

## Midterm Grade Replacement Policy:

Due to comprehensive nature of the final exam, if a student's score on the final exam (on a percentage basis) is higher than a midterm exam score, I will replace the **lowest** midterm exam score with the percentage score achieved on the final exam.

## **Group Projects**

There are three group projects, as noted on the daily plan. The first group project focuses on inventory and requires the students to find and read a company's financial statements. The second group project focuses on the Codification and contingent liabilities. More information about the group projects and their specific requirements will be discussed in class and posted on Carmen. The last is a debate that will happen over Zoom.

#### Homework

Homework is to be done through the Connect. The due dates are listed on the daily table. Connect will automatically deduct 10% from your assignment grade for every hour the assignment is late. Because the homework is to be done online please give yourself plenty of time to complete the homework in case of technology complications. You will have 11 assignments. Ten will be for included in your final grade (each worth 10 points) and the lowest assignment grade will be dropped. The homework is problems based and is designed to help prepare you for the midterm and final.

## **Individual Assignments**

There are 2 assignments posted on Carmen and should be turned in on Carmen. These cases are to be written up individually, although you are allowed to talk to your classmates about the assignments. They will be graded on a check, check minus system.

## **Attendance and Engagement**

Attendance and being actively engaged are expected in the business world, and are expected in this course. Engagement in the class is for your own benefit. Those that wish to disrupt the class will not be permitted to stay in the classroom.

Students will have the option of attending class either in-person once a week and via Zoom the other day or attend entirely via Zoom. There will be questions that I ask during the lecture that you will need to respond to via Tophat. Tophat will grade these question 80% on participation and 20% on accuracy.
