Course Description

This course covers a study of the federal income tax treatment of business entities including regular corporations (C-Corporations) and flow-through entities (partnerships and S-Corporations). We will also cover accounting for income taxes in the financial statements.

Course Objectives

This course is designed to acquaint students with the workings and concepts of the federal tax law, particularly as it pertains to the various types of business entities and their owners. This course is not structured to provide an exhaustive review of these subjects or to serve as preparation for professional exams. However, it is my hope that students in this course will gain a strong working knowledge of the topics covered and that this introduction will form a solid foundation upon which further undergraduate or graduate-level study of these topics can build.

Prerequisites

Students should have successfully completed Tax Accounting I (AMIS 3400) or equivalent.

While this format provides for ample flexibility should students need it, waiting until shortly before an exam to watch all recorded lectures is strongly discouraged. In the event a student misses a scheduled lecture, the student is responsible for viewing the lecture on Carmen and ensuring they understand the material **prior** to the next class meeting. Students having questions about the material should always feel free to attend my office hours or email me after watching the respective lecture, even if they were not able to watch the live lecture originally.

Students are expected to be prepared for each class period, to actively participate, and to have their camera on during lecture. I reserve the right to "cold call" students regarding questions from lecture. As with any classroom setting, students are expected to exhibit professional behavior during lectures. This includes, but is not limited to: ensuring you are on mute when not actively speaking in class (i.e., when not answering or asking a question), silencing your cell phone and paying attention, and not participating in any other disruptive behavior.

Assignments

To encourage active participation and help reinforce the concepts covered in class, I have created eight assignments (one for each chapter in the course schedule) in Carmen for completion. The assignments are open book and open note but must be individually completed. Your lowest grade out of these eight assignments will be dropped. Each assignment will be officially due by 11:59 PM EST on the dates listed on the syllabus. Late assignments will not be accepted.

Examinations

There will be four (non-cumulative) examinations in this course featuring a variety of true-false, multiple choice questions and problems based on material discussed in-class and in the textbook. Exams are closed book and closed notes and will be taken on Carmen. Students will have a 48-hour window during which to complete the exam. This window will open at 6:00 AM EST the day of the exam (as listed on course schedule) and will close 48 hours later. Failure to complete and submit the exam before the deadline will result in the student receiving a zero unless documentation supporting an exam absence is provided. Documentation must be dated the day of or the day before the exam. It is the responsibility of the student to contact me directly if issues arise with the exam. As noted below, students are expected to uphold academic integrity in all facets of academic activities, including exams. Thus, students are not permitted to work with other students on the exam or discuss the exam with other students (in their section or other sections) who have not yet submitted their exam.
