<u>Course Materials</u>: Required: Kubasek, Nancy. Dynamic Business Law. New York: McGraw-Hill, 2025 Release. The book is on Carmen books. Hard copies are also available. Connect is not required for this course. The earlier editions do not contain all of the cases we will cover. Additional material will be posted on Carmen.

<u>Course Description</u>: This course is an introduction to the U.S. legal system and sources of law and an analysis of basic legal concepts related to business decisions. Primary areas covered include torts, contracts and employment law. It will involve discussion, questions and answers on the materials, and case studies. Class participation will be expected. Students will be expected to discuss the cases and problems in each chapter covered. In-class quizzes may be given and homework will be required. 1.5 credit hours.

### **Course Learning Outcomes:** By the end of this course, students should:

- understand the legal framework within which American business operates
- be familiar with basic legal concepts relevant to business decisions
- have gained experience in legal analysis
- have improved their communication skills

### **How This Course Works:**

**Mode of delivery:** This course is 100% in-person. There is the possibility of Zoom review sessions if students have an interest in holding them. Homework assignments are on Carmen.

Credit hours and work expectations: This is a 1.5 semester credit hour course. Since it only meets for half of the semester, according to Ohio State policy, students should expect around an average of 3 hours per week of time spent on direct instruction (time in class) in addition to 6 hours of homework (reading and assignment preparation, for example).

Participating in class: You will be expected to have read the assigned reading for each session. You will be expected to be prepared to discuss the assignment and may be called on. . I know that students feel differently about being called on in class and that some students may find it stressful. If you are one of those students who feel uncomfortable being called on please come to office hours and we can discuss the situation and develop options on how to proceed. I want everyone to feel comfortable in class so that they can focus on the material.

**Office hours:** Coming to office hours is optional; however, based on your class performance you may be requested to schedule a meeting to discuss your progress.

<u>Attendance Policy</u>: Any student who fails to attend without giving prior notification to <u>me may be dis-enrolled after the third instructional day of the term, the first Friday of the term, or the second scheduled class meeting of the course, whichever occurs first.</u>

Class discussion and participation will be an important part of this class and cannot occur without attendance. Attendance is not required (except as noted above regarding dis-enrollment) but will affect your participation grade. If you know you will be unable to attend class or complete a homework assignment on time and are requesting an excused absence, please email me **BEFORE** the scheduled class or the due date of the homework. Please do not request an excused absence with a general statement like "family emergency." The individual facts and circumstances will determine if an absence is excused. If you are not requesting an excused absence you do not need to email me. Your email should contain both the course number (3500) and time of class in the subject line so that it gets to the proper mailbox. **Emails not containing the course number and time in the subject line will be disregarded**. If you email me and have not received a response

within 24 hours, assume the email was not received and either resend or contact me by phone. If you miss an assignment and believe you have an acceptable reason, please contact me as soon as possible. Any adjustments are entirely within my discretion. If you have a job interview that cannot be scheduled at a time that will not conflict with class, please provide the name of the employer and name, email address and phone number for a contact person at the employer. You should attend another section of the class if it does not conflict with your schedule. Missing an exam without notifying me prior to the exam may result in a zero for the exam grade.

Examination Policy: There are no make-ups for in-class quizzes. Missed quizzes will be recorded as a "0." Missed exams can only be made-up in extreme cases (e.g., death of family member, personal hospitalization, etc.) with proper documentation (e.g., a physician's note, ER paperwork, obituary, etc.). Each decision of potentially allowing a make-up exam is made on a case-by-case basis in my sole discretion. Additionally, you MUST contact me as soon as you know of a potential problem or conflict with an exam date. Alternative methods (e.g., oral exam, essay) of testing may be used for make-up exams. If you are experiencing an extreme situation or emergency, please attempt to notify me by email ASAP. Failure to show up for an exam without prior notice may result in a zero for the exam.

<u>Communication:</u> The best way to reach me is by email. If you would like to notify me regarding an absence it should be by email. Unfortunately, I cannot guarantee that I will remember everything I am told before or after class, especially when I have several classes in a row so that is why I require an email. Your email should contain both the course number and time of class in the subject line so that it gets to the proper mailbox. <u>Emails not containing the course number and time in the subject line will be disregarded</u>. If you email me and have not received a response within 24 hours, assume the email was not received and either resend or contact me by phone.
