Course Materials: Required: Kubasek, Nancy. Dynamic Business Law. New York: McGraw-Hill, 2025 Release. The book is part of the Carmen book program. You can opt out if you have another source for the book. Connect is not required for this course. The earlier editions do not contain all the cases we will cover. Additional material will be posted on Carmen.

Course Description: The primary objectives of this course are to provide students with an understanding of the legal issues facing American businesses. It will cover issues not covered in BUSFIN 3500 and will provide additional experience in legal analysis. You should take 3500 prior to taking 4510. Class will involve discussion, questions and answers on the materials, and case study. Class participation will be expected. Students will be expected to discuss the cases and problems in each chapter covered. In-class quizzes may be given, and homework will be required. 1.5 credit hours.

<u>Course Learning Outcomes</u>: By the end of this course, students should:

- understand additional legal areas not covered in BUSFIN 3500 and their effect on how American business operates
- be familiar with the substantive legal areas covered on the CPA exam
- further developed their ability in legal analysis
- have improved their communication skills

How This Course Works:

Mode of delivery: This course is 100% in-person. There is the possibility of Zoom review sessions if students have an interest in holding them.

Credit hours and work expectations: This is a 1.5 semester hour course. Since it only meets for half of the semester, according to Ohio State policy, students should expect around an average of 3 hours per week of time spent on direct instruction (time in class) in addition to 6 hours of homework (reading and assignment preparation, for example).

Participating in class: You will be expected to have read the assigned reading for each session BEFORE CLASS. You will be expected to be prepared to discuss the assignment and may be called on. If you have a situation that might cause you to miss a class, please contact me via e mail BEFORE the scheduled class. If you tell me before or after class, please also follow up with an e mail as I may not remember our conversation. I know that students feel differently about being called on in class and that some students may find it stressful. If

you are one of those students who feel uncomfortable being called on please come to office hours and we can discuss the situation and develop options on how to proceed. I want everyone to feel comfortable in class so that they can focus on the material.

<u>Attendance Policy</u>: Any student who fails to attend without giving prior notification to me <u>may be dis-enrolled</u> <u>after the third instructional day of the term</u>, the first Friday of the term, or the second scheduled class meeting of the course, whichever occurs first.

Class discussion and participation will be an important part of this class and cannot occur without attendance. Attendance is not required (except as noted above regarding dis-enrollment) but will affect your participation grade. If you know you will be unable to attend class or complete a homework assignment on time, please email me **BEFORE** the scheduled class or the due date of the homework. Your email should contain both the course number and time of class in the subject line so that it gets to the proper mailbox. **Emails not containing the course number (4510) and time in the subject line will be disregarded.** If you email me and have not received a response within 24 hours, assume the email was not received and either resend or contact me by phone. If you miss an assignment and believe you have an acceptable reason, please contact me as soon as possible. Any adjustments are entirely within my discretion. Examination Policy: There are no make-ups for in-class quizzes. Missed in-class quizzes will be recorded as a "0." Each decision of potentially allowing a make-up exam is made on a case-by-case basis in my sole discretion. A student may not be penalized for an absence approved under this policy.
