<u>Course Description:</u> This course introduces you to the American legal institutions, sources of law, and an analysis of basic concepts of private and public law related to business decisions.

<u>Instruction Method:</u> Flipped classroom. *See*, https://teaching.resources.osu.edu/glossary/term/flipped-classroom . Here's how it will work in this course:

- 1. On or about 6:00 p.m. E.T. Friday, before starting the next week's module, I will post on Carmen an announcement, *Summary of Assignments for Week X* (where X = the number of the week for the module) in the *Announcements* section of Carmen. The assignments listed therein for that week's module will be:
 - o a reading assignment of a chapter in the B&K textbook;
 - o a viewing assignment of recorded lectures (the video link for each lecture will be in a separate announcement in the Announcements section on Carmen); and,
 - a homework assignment (described in more detail in a separate post in the Assignments section of Carmen). The homework assignment usually will be a short (200 400 word) written assignment, to be uploaded on Carmen on or before the stated due date. Occasionally, the homework assignment may be a quiz to take and submit on Carmen. The homework assignment will usually be due on or before 6:00 p.m. Saturday, the day after we finish discussing that module. For written assignments, you can generally expect feedback within seven days.
- 2. When we are in class together, I will lead a discussion of the assignments (reading, recorded lectures, or homework), emphasizing the questions/problems that follow the subtitle: "Business Application" in each chapter, the weekly written assignment, and any quizzes. You should be prepared to discuss the material, and you should use our time in class to ask questions. Our time together will be better spent if everyone comes to class prepared to discuss the material and to ask questions, which can benefit all.

<u>Communication:</u> The best way to reach me is by email. If you email me and have not received a response within 24 hours, assume the email was not received and resend it.
