**CarmenCanvas:** I post information about the course on CarmenCanvas. Be sure to sign up on CarmenCanvas to receive announcements and other notifications. There's an old saying, "Ignorance of the law is no excuse." Ignorance of posted announcements won't excuse nonperformance of a course requirement. So, don't miss out; sign up for getting announcements in CarmenCanvas.

**Office Hours:** My office hours are Tuesdays from noon to 2:00 and by appointment via Zoom. We can usually conduct our business in 15 minutes. To see me during office hours, send me an email asking to schedule a meeting, and I'll send you a Zoom meeting invitation that includes the Zoom link for the meeting. If you want to meet outside of my regular Tuesday office hours, send me an email and give me three (3) days and times that are convenient for you. Usually one of those alternatives will work.

**Required Course Materials:** Essentials of the Legal Environment of Business: Applications and Ethical Considerations, **Third Edition** (ISBN: 978-1-71147-106-8) (XanEdu 2022) by Blackburn and Klayman (hereinafter *B&K*), available at Barnes & Noble-OSU Bookstore. On the inside cover of the hardcopy text is a code that provides you with access to the digital version of the book.

Additional online required reading material will also be assigned periodically. This material is usually about a current event that is relevant to the course. Link(s) to this material will be sent to you through the Announcements function of CarmenCanvas. Check regularly your email and the Announcements section in CarmenCanvas so you won't miss this required reading material, which we will discuss in class.

**Course Description:** An introduction to American legal institutions, sources of law, and an analysis of basic concepts of public and private law related to business decisions.

**Course Learning Outcomes:** By the end of this course, students should be able to:

- Demonstrate a foundation-level knowledge of the characteristics and concepts generally associated with the U.S. legal environment of business. A few examples of, in general, characteristics of U.S. law are: democratic, rationalist, and pragmatic. Some examples of legal concepts are: the requirements of contracts; and, the elements (that is, required proof) of torts, which are those acts that, if carried out and cause harm, make the actor liable for the harm that was done.
- Engage in analysis and problem-solving skills enabling the student to identify and critically assess legal problems facing contemporary businesses.
- Identify and address ethical issues surrounding business decisions.

**Course Format:** Lecture and discussion. You read that right: *discussion*. Our time together will be spent better if we all come prepared to discuss the assigned material. I welcome your questions and your thoughts about the material. I will call on students (It could be you!) to challenge and develop their critical thinking and problem-solving skills.

**Communication:** The best way to reach me remotely is by email. Include the time your section meets in the subject line of your email if you want me to answer it. If you email me and haven't received a response within 24 hours, assume the email was not received and resend it—and double check to see you have included the time your section meets in the subject line!

**Evaluation and Grading:** Your course performance will be based on your point score out of a total of 100 points on (1) six homework quizzes (total quiz points possible: 30); (2) a midterm exam (total points possible 30); and (3) a final exam (total points possible: 40).

Each quiz will be on a chapter we cover and any related online material that is also assigned. You can expect about 5 questions per chapter, with each question worth one point. However, some quizzes are shorter or longer than 5 questions. The number of questions on any given quiz usually depends on (1) the number of classes assigned to cover the chapter, (2) the length of the chapter, or (3) the amount of assigned online material reflecting current events. Questions may be of the true-false and/or multiple-choice format.

The midterm exam will have 30 questions, worth one point each and which may be of the true-false and/or multiple-choice format. The final exam will have 40 questions of the same format and worth one point each. The allotted time for the exams will be (a) one hour for the midterm, and (b) two hours for the final.

All quizzes and exams are conducted on CarmenCanvas (It calls both quizzes and exams, "quizzes.") and which I post in the Quizzes section of CarmenCanvas. I will post each homework quiz on CarmenCanvas shortly before we start the discussion of an assigned

chapter. The quiz will be due at 6:00 p.m. ET the class day we end coverage of the chapter. Each quiz is open book, open note, with more than one attempt allowed, and collaborative. You may complete quizzes with others. Because you will have several days to complete each quiz, late submissions for quizzes will not be accepted. Take note of each quiz's due date, as you will not have an opportunity to make up quizzes. The quiz will be locked after the due date, and if the quiz is not complete, you will receive a zero for that quiz. I suggest that you do the assigned reading for a given class, then answer the quiz questions before class. That way you can get a feel for how well you understand the material covered by the questions and know what to ask about in our class sessions; and, I can review the CarmenCanvas statistical report for the quiz, and get a feel for how students are understanding the material before class. All this helps me decide what to focus on in our class discussions.

The midterm and final exams are also conducted on CarmenCanvas. They will be available from 12:00 a.m. to 11:59 p.m. on the day the exam is scheduled. They are open book and open note, but you will have only one attempt (one-hour duration for the midterm, and two hours duration for the final), and you cannot collaborate with any other person or thing before or during these exams. The purpose of the midterm is to give you feedback on how you are doing in the course at the midway point; the purpose of the final is to evaluate your knowledge of the course content at its end. (Therefore, the final exam will cover all the material covered in the course from start to finish.) To repeat what was stated earlier, the midterm will have 30 questions, and the final will have 40 questions, the questions on each exam may be of the true-false and/or multiple-choice format, and the questions will be worth one point each.

See the Course Schedule, below for the days the quizzes are due, and for the days the midterm and the final exams are scheduled. (Remember, the deadline for each of the exams will be 11:59 p.m. the day the exam is made available on CarmenCanvas—so be sure to start your exam early enough to allow you the allotted time to take it—one hour for the midterm; two hours for the final.)

The following is grading scale that will be applied to your total point score at the end of the course to determine your course letter grade:

#### **APPENDIX**

### STATEMENTS CONCERNING UNIVERSITY POLICIES AND SERVICES
