Course Description:

The primary objectives of this course are to provide students with an understanding of the legal issues facing American businesses. It will cover issues not covered in BUSFIN 3500 and will provide additional experience in legal analysis. You should take 3500 prior to taking 4510. It will involve discussion, questions and answers on the materials, and case study. Class participation will be expected. Students will be expected to discuss the cases and problems in each chapter covered. Quizzes may be given, and homework will be required. 1.5 credit hours.

Course Learning Outcomes:

By the end of this course, students should:

- understand additional legal areas not covered in BUSFIN 3500 and their effect on how American business operates
- be familiar with the substantive legal areas covered on the CPA exam
- further developed their ability in legal analysis
- have improved their communication skills

How This Course Works:

Mode of delivery: This course is 100% in-person. There is the possibility of Zoom review sessions if students have an interest in holding them.

Credit hours and work expectations: This is a 1.5 semester hour course. Since it only meets for half of the semester, according to [Ohio State policy](#), students should expect around an average of 3 hours per week of time spent on direct instruction (time in class) in addition to 6 hours of homework (reading and assignment preparation, for example).

Attendance and participation requirements: Attendance is not required; however, participation is part of your grade and participation cannot occur without attendance. The following is a summary of everyone's expected participation:

Attendance Policy:

Any student who fails to attend without giving prior notification to me **may be dis-enrolled after the third instructional day of the term**, the first Friday of the term, or the second scheduled class meeting of the course, whichever occurs first.

Class discussion and participation will be an important part of this class and cannot occur without attendance. Attendance is not required (except as noted above regarding dis-enrollment) but will affect your participation grade. If you know you will be unable to attend class or complete a homework assignment on time, please email me BEFORE the scheduled class or the due date of the homework. Your email should contain both the course number and time of class in the subject line so that it gets to the proper mailbox. **Emails not containing the course number and time in the subject line will be disregarded.** If you email me and have not received a response within 24 hours, assume the email was not received and either resend or contact me by phone. If you miss an assignment and believe you have an acceptable reason, please contact me as soon as possible. Any adjustments are entirely within my discretion. If you have a job interview that cannot be scheduled at a time that will not conflict with class, please provide the name of the employer and name, email address and phone number for a contact person at the employer. You should attend another section of the class if it does not conflict with your schedule. Missing an exam without notifying me prior to the exam may result in a zero for the exam grade.

Examination Policy:

Exams: There will be two exams in this course, a Midterm and a Final (the “Exam(s)”). The Exams will be given in class on your device through Carmen. The Midterm is currently scheduled for January 29, 2024, and the Final is currently scheduled for February 23, 2024 (the “Exam Day(s)”).

- You will be expected to take the Exams in class on the Exam Days unless you are taking an Exam through SLDS or have made other arrangements with me prior to the Exam Day.
- Failure to take an Exam on the Exam Day without my express permission will result in a score reduction based on the following schedule:
 - Automatic 10% score reduction for an exam not taken on Exam Day without prior arrangement and notification.
 - 20% reduction for an Exam taken a week after Exam Day
 - 30% reduction for an Exam taken two weeks after Exam Day.
 - You will be ineligible to receive any points for an Exam if you do not complete it within two weeks of Exam Day. The score will be 0.
- Exams taken outside of the classroom must be administered by the SLDS or the Testing Center – no exceptions.

Communication:
