#### **Course Materials:**

## **Course Description:**

This course is an introduction to the U.S. legal system and sources of law and an analysis of basic legal concepts related to business decisions. Primary areas covered include torts, contracts and employment law. It will involve discussion, questions and answers on the materials, and case studies. Class participation will be expected. Students will be expected to discuss the cases and problems in each chapter covered. Homework is required. 1.5 credit hours.

## **Course Learning Outcomes:**

By the end of this course, students should:

- understand the legal framework within which American business operates
- be familiar with basic legal concepts relevant to business decisions
- have gained experience in legal analysis
- have improved their communication skills

## **How This Course Works:**

**Mode of delivery:** This course is 100% in person. There is the possibility of Zoom review sessions if students have an interest in holding them.

**Credit hours and work expectations:** This is a 1.5 semester credit hour course. Since it only meets for half of the semester, according to <u>Ohio State policy</u>, students should expect around an average of 3 hours per week of time spent on direct instruction (time in class) in addition to 6 hours of homework (reading and assignment preparation, for example).

**Attendance and participation requirements:** Attendance is not required; however, participation is part of your grade and participation cannot occur without attendance. The following is a summary of everyone's expected participation:
